1. The Houston VA Medical Center is the
first hospital in Texas and the first VA
hospital to install a computerized system
able to integrate all steps required for
surveillance on "Methicillin-resistant

Staphyloccus Aureus" (MRSA) including testing, sample preparation amplification, and detection. MRSA is a serious form of a common form of bacteria that frequently inhabits the skin or nostrils of healthy Due people. to it's resistance to antibiotics commonly used in treatment, MRSA is one the most rapidly growing and virulent health care associated infections, and according to the Centers for Disease Control Prevention and (CDC) responsible for over 100,000 hospitalization each year. The new computerized system at Houston VA Medical Center utilizes real-time polymerase chain reaction (PCR) to amplify and detect target bacteria. The system provides PCR test results from a raw sample in 70 minutes or less, enabling time critical tests and treatment quickly. Under current procedures the laboratory testing can take up to several days to deliver results, thus allowing the spread of the infection and increasing the risk of death. MY OPINION: Once again we're at the head of the line.

Veterans National Information 1. The House Armed Services Sub-Committee approved HR1585, the National Defense Authorization Act that included (a) a 3.5% active duty pay raise. (b) An increase of force levels by 46,500 troops; Army 36,000 troops; Marines by 9,000 troops; Air Force by 963 and the Navy by 698 to replace medical personnel transferred to the other services. (c) Transferring responsibility and costs for the Reserve Forces Montgomery GI Bill from the DOD the VA. (d) Disapproval of Administration's requested increase TriCare fees, drug costs and co-pays, for 2008. (e) Better screening for PTSD symptoms, citing problems of troops requesting care and being ignored at the Army Hospital at Fort Carson in Colorado. MY OPINION: I stated previously that

Walter Reed was not the only Military Hospital problem. The TriCare fee increases will be back again next year.
