# TEXAS MILITARY AND VETERANS LICENSE PLATE CHANGES

The 80th Texas Legislature improved vehicle licensing. Eight license plate bills were passed and signed that may impact vou. These were: SB11 - Created new specialty plate designs; HB-191Standardized Military Specialty Plates and fees by category; SB0251 - Amended Disabled Veteran Parking Privileges; HB2105 -Allows a Disabled Veteran two parking placards. These bills created new Military Specialty Plates: HB2282 – Legion of Merit; SB0274 - Silver Star and HB3857 - Gold Star Spouse and Gold Star Family. SB959 -Allows the International Symbol for Access (ISA) on all "specialty plates" produced by the State of Texas.

The Disabled Veteran (DV) plate has been a problem for some time. The use of that plate had its own volume of rules it seemed. If the jurisdiction (city, county, or government agency) allowed, the DV plate was permitted in "handicapped parking". The problem was – knowing which jurisdictions did and which jurisdictions didn't was nearly a full time job.

If you are rated at 50% disabled by the Department of Veterans Affairs and receive compensation from the United States because of the disability, you may apply for the Disabled Veteran (DV) plate. If you are rated as 40% disabled as a result of amputation of a lower limb you may also apply for the DV plate. A medical endorsement (doctor's signature) will allow you the ISA. The ISA can be applied to the DV plate or ANY OTHER specialty plate made by the State of Texas. There are two parts to this change: (1) the plate with the ISA can only have five characters. That may mean you may sacrifice 'PH' on a Purple Heart Plate to get the ISA. The Purple Heart Medal is present, the text "Purple Heart" is still on the plate. (2) The plate with the ISA is developed digitally so flexibility. there is some

House Bill 2105 allows the DV to apply for two disabled placards on the same form for which one applies for the DV plates. Those currently having two sets of DV license plates may use the application to request the placards without going to a physician (Form VTR 615).

Senate Bill 0251 allows Disabled Veterans to park in any disabled parking space without the requirement of an ISA on the license plates or displaying a disabled person placard as long as the vehicle has DV license

plates.

Four new plates were developed - Silver Star, Legion of Merit, Gold Star Spouse and Gold Star Family. Any and all specialty plates may now have the ISA. That includes the Congressional Medal of Honor, Legion of Valor, Silver Star, Congressional Delegation, National Guard ('Minute Man') and Yes, the Gold Star Mother, Spouse or Family. Please know the first few requests for specialty plate with the ISA may take a little while and will generally have a maximum of five characters. These are new issues and programming must be developed, so be patient. This programming is expected to be completed by mid-February, but until then you may request an application through the Vehicle Title and Registration Division's Special Registration Branch in Austin. # <u>SPECIAL POSTAL RATES</u>

Beginning 3 MAR Military families will get a price break on the U.S. Postal Service's flat-rate shipping boxes to send care packages around the globe. The discount applies only to the new "Priority Mail Large Flat-Rate Box," which normally carries a \$12.95 price tag for shipping. However, when the 12-by-12-by-5.5-inch box is sent to an AFO or FPO address, a \$2 discount applies, dropping the cost to \$10.95. The new boxes will be available in post offices nationwide on 3 MAR.
