The finance officer, **Dave Lips**, reported a General Fund of \$13,415.15 and an Allocated fund of \$20,558.52. The General Fund is used to pay the every-day expenses while the allocated fund has allocations for a post home, veteran affairs and rehab (VA&R) among others.

We currently have 354 members for 2009. We need 413 to reach our goal. We have a team of ten members who are actively calling members who have not renewed for 2009 and asking them to renew. We want to reach a goal of 433 members so that we can again become a Hall of Fame Post.

**Chuck Suhr**, the 2d Vice Cdr. noted that the rummage sale will be coming up on April 18th. Next meeting he will have a sign-up list for people to volunteer a specific time to help at the set-up on Friday and the sale on Saturday. He also recommended that the Post not continue to try organizing attendance at a baseball game. He found little interest among members.

VA will enroll about 265,000 additional veterans in this category (Non-Service Connected, Income Qualifying). Income cutoff will be increased from \$30,000 to \$32,342 for a single veteran plus \$2,222 for each dependent.

# HASS DECISION OVERTURNED

The Supreme Court refused to hear the appeal on this matter, so the lower court decision is final. This decision says that veterans who served in Thailand and in ships off the coast of Vietnam are not entitled to presumptive exposure to agent orange. Claims that have been held in abeyance pending this decision will not be processed.
