### VETERANS ADVOCATE

As you probably know, during the last couple of years, the Houston Bar Association, together with the Houston Volunteer Lawyers Program, has been providing free legal clinics at the VA Hospital, several residence facilities, and some selected American Legion and VFW Posts. I have been working with them on this project, and, in furtherance of the effort, we will be providing 20 or more lawyers and support staff to assist veterans and their spouses, on November 14, 2009, at American Legion Post 560, 3720 Alba Road, Houston, Texas 77018, from 9:00 am until all clients are assisted. There is no charge for the services, and no reservations are necessary. It is first-come, first-serve.

This pilot program has been a wonderful success, has helped hundreds of veterans and their spouses, and has caught the eye of the State Bar of Texas, whose president, Terry Tottenham, will be in Houston on November 13th to begin the process of organizing the program on a statewide level. I will attend that meeting.

I would very much appreciate your assistance in getting the message out to every post in the division, to give every veteran or spouse of a veteran notice of the coming free clinic at Post 560. Obviously, we want the biggest turnout possible, and, at the last clinic, there were approximately 40 clients who received free legal assistance. If the problem presented at the clinic requires more than an initial interview, the Houston Volunteer Lawyer Program will appoint the veteran or spouse an attorney, who will represent the client to the conclusion of the problem, at no charge to the veteran nor the veteran's spouse. They handle virtually every kind of legal problem, including wills and estates, property matters, landlord-tenant problems, financial disputes, family matters, probate, general civil matters, consumer complaints, disability claims and claims involving veterans' benefits. They do not handle criminal matters. In order to get free legal assistance, the veteran or spouse may not have an annual income which is greater than approximately\$90,000peryear.

Would you notify all the posts in our division of this opportunity. We want this to be a great success, since, if it does well, we could have such clinics operating in every part of Texas in the very near future. Thank you. Bryan Coleman

Discounts at Retail Stores. I read post saying that there is a 10% military discount for Active Duty, Reserve, and Retired Military at Lowes and Home Depot. Dependent ID also seems to be accepted.

I called Lowes Customer Care Center and was told the customer should to show a military ID card and request a discount at the time of check-out. The discount is usually 10%. Right now, there does not seem to be a limitation on the dates or time of year this discount is available, but that is subject to change.

Customer Care at Home Depot read me their policy. By presenting a valid military ID, military and their immediate families can receive a discount at check out for Memorial Day, the 4th of July, and Veteran's Day. The policy is silent as to whether or not it is just on those dates or if it applies a few days before or after. That seems to be a manager decision, so you might contact the store before hand.

What I did learn in my search is that it is reasonable to start all of your shopping by searching the web for military discounts. It also seems to be reasonable to ask any national chain store (from auto parts to clothing) or any national chain restaurant if they provide a military discount -- such as the store I shopped at last night and didn't have any idea I should have asked. Seems like that also is a particularly reasonable question of you are getting food from a national chain drive-up window -- quite a number of those, but not all, from what I could tell.
