#### **MEETING HIGHLIGHTS**

**Commander Ison** opened the meeting and determined a quorum was present. Finance Officer **Dave Lips** reported on Post finances. The General Fund total was \$13,549.27 and the Allocated Fund total was \$21,262.24 for a grand total of both funds of \$34,811.61.

The current membership report was given by 1<sup>st</sup> Vice Commander **Kimberly Biggerstaff**. As of the 9/16 meeting, paid membership stands at 233, which

**Mickey Fussell** reported on progress inventorying all Post property and the consolidation of all Post-owned property at a single location. The last inventory was made in 2005.

We are invited to join other participants at Anadarko Tower for an indoor ceremony – 10:00 AM to 1:00 PM. The City of Houston has also invited Legion Posts to its Veterans Day Parade. #### VETERANS ADVOCATE MORE ORANGE AID

For those of you who served in Vietnam (or along its borders with Cambodia or Laos) and were, or may have been exposed to Agent Orange, the VA has completed its update of the Agent Orange Act of 1991 and will now entertain claims of damages in the form of three additional diseases, to wit:

- ~ Parkinson's Disease
- ~Hairy Cell and other Chronic B-Cell Leukemias, and
- ~Ischemic Heart Disease

Evidence provided in support of "presumptions" of service connection no longer requires proof of association between medical problems and military service, simplifying and accelerating the application process. All prior applications rejected involving these diseases will be reconsidered.

#### PTSD COMPENSATION

As of July, the VA published new rules which reduced evidence needed to support a posttraumatic stress disorder claim. While each such claim will be evaluated and require confirmation by a VA psychiatrist or psychologist, the new process is expected to allow more accurate decisions toward award of medical care and other VA benefits.

#### TRICARE IMMUNE TO OBAMACARE

It has been confirmed by the VA that the Patient Protection and Affordable Care Act will have no impact on the TRICARE medical health plan. Matt Flavin, Director of Veterans and Wounded Policy, stated Warriors that: "There is absolutely nothing in health reform that will affect TRICARE benefits." Furthermore, the House of Representatives unanimously passed HR4887, the TRICARE Affirmation Act. providing assurance to those in the military and their families of TRICARE meeting the requirements for coverage.

#### SONS AND HOGS

If you remember back four years to September 2006, you will recall the membership voted to establish a motorcycle branch – "The American Legion Riders Chapter of The Woodlands", so, I assume, dormant ("tabled") among Old Business is the implementation of that initiative. Now, I'm not a hog advocate and do not intend to "wake sleeping dogs", but I am a former SAL member, and that's my real subject.

When I was qualified by age and had a father who was a dedicated and devoted Legionnaire (Post 291, Department of Massachusetts), I joined the Sons of the American Legion and participated the squadron's meetings, in parades and programs. That was when all Legionnaires had only WWI as a "war era". I do not remember what motivated me to join, but it was obviously my parents, who also urged me into being a Boy Scout, a DeMolay member, a Soap Box Derby entrant and a regular Sunday school attendee.

My squadron met just in advance of the monthly Post meeting and so I, along with others, sat Post through the meetings. impressed by the ceremony, to our benefit. The grand events, to me, were the parades, five per year-- Bunker Hill Day (or Patriots' Day), Decoration Dav (or Memorial Independence Day), Day, Armistice Day and another regular ceremony just in advance of Memorial Day where those who died at sea were honored at the shoreline. Enough of that!

In the August issue of The Bugle, Commander Ison cited his advocacy for forming an SAL squadron at this Post. He announced that the August 19th meeting would be preceded by an open discussion of the subject, starting at 6:00 PM. The Commander was there with a cadre of officers. including Auxiliary Unit members. He had a slide or DVD presentation ready to run. As time went by, the audience he hoped for - parents and grandparents of sons - failed to appear. The projector was dismounted and put away and the session planned did not take place. It was approaching 7:00 PM.

In retrospect, what circumstances caused this apparent disinterest? Was the notice not adequate or too late? Possibly. Have the parents of sons gone missing, like the Harley Hog enthusiasts? I know the Legion has long since differed from the Legion of the 1940's, when dad was a hero who survived the short US role in the Great War, but, other Posts have active squadrons today. Let's not give up, but continue to try for a consensus among our members. And, with proper representation, call for a "sense of the Post". Win Salter

#### THE B-47 STRATOJET

The sleek and highly advanced B-47 occupied Boeing an important place in the defense of the US. Its prime service years were mid-1950's to mid-1960's. With a crew of just three, this medium bomber had the primary mission to deliver nuclear bombs on bad guys. It was a major Cold War deterrent and never

experienced combat conditions, if you exclude MIG intercepts of reconnaissance flights. The B-47, with a maximum speed in excess of 600 mph, could outfly most interceptors of the day and handled like a fighter plane. Its sole defensive armament was a tail turret housing two 20 mm cannons. The co-pilot doubled as tail gunner and the navigator doubled as bombardier. It was the first US combat aircraft to have swept-back wings. B-47 squadrons of SAC were based at forward bases bracketing the Soviet Union - in the UK, Morocco, Spain, Alaska, Greenland and Guam. Often one-third of operational B-47s were armed and ready on alert ramps with crews on stand-by. As the longer range B-52 assumed nuclear strike duties, the number of B-47 wings began to be reduced. The last units - recon squadrons were re-equipped or disbanded in 1969. We owe much to these Cold Warriors!
