A new program developed by National allows members to reinstate or renew their membership by paying dues on line. To learn more about the program visit www.legion.org. Select the "renew now" button (located on the right hand side of the screen) and several videos become available that explain the new program. To renew your membership, type in your name or membership number, and a screen pops up with the information National has on you on file. You can pay dues with a MasterCard, Visa or Discover card. A one-piece form with a built in Thank You, Temporary Membership Card and dues receipt can be printed. The original will be mailed to you from National. Post 305 **Adjutant Pickens Jones** will be notified two times per month of renewing members. He, in turn, will mail

your original membership card to you. It's a good program, saves you time, postage and paperwork. Another benefit is that once you enter the debit/credit card information, you're set up for next year, if you choose to pay your dues on line again. It's a good program so give it a try.

MEETING HIGHLIGHTS **(July 21, 2011)**

Commander Kim Biggerstaff opened the meeting in the customary manner and called on the Adjutant for a silent roll call. A quorum was present. She then called on those present to review for approval the minutes of the previous meeting and those of the Executive Committee meeting of July 18. With some discussion, both were adopted by motion. The Commander called on the Sergeant-at-Arms to identify any guests present. He introduced **Victoria Glover**, a former service member who requested transfer to Post 305, and **Robert Sullivan**, student at Woodlands High and a

Junior ROTC cadet. Young Sullivan offered to assist the Post in any of its projects.

Finance Officer Dave Lips gave the current financial report, summarized as follows:

~General fund----- \$14,908.41
~Allocated fund----\$22,507.53
~Total assets----- \$37,415.94
(as of 6/30/2011)

First Vice Commander Emery Heuernann reported on membership but had no to-date total due to new-year complications. These are just "growing pains" due to a changed system. The Vice Commander has been analyzing the roster to plan his 2012 campaign to attract earlier dues payments.

Service Officer Dayton Denton suggested that the Post invite all 12 Boys State grads (and their parents) to the Post's November 17 meeting, where the traditional Thanksgiving feast will be featured. This was agreed. **Dayton** also suggested that potential sponsors of Boys State participants be invited too as a means of encouraging donors. The Post is budgeting for four boys at \$275 each, but will aim for more using contributed funds.

The Commander displayed the mounted plaque presented by the Department, recognizing the Post's History Book, ranked first by the judges. **Historian Win Salter** cited the books available for perusal on a table at the rear of the room.

David Lips reported there are four pledges unfulfilled from the Birdies-for-Charity fund raiser and that the Post's "take" would not be received until October or November.

The Commander reminded all that the Fall Rummage Sale is coming

up in October and that articles for sale are needed, especially "big ticket items". But, **Dayton Denton** added that the single storage locker was almost full. That means Post donors should hold their treasures, then transport those to the sale site on set-up day, with trucking help on request.

Under "Unfinished Business", the Commander brought up our July 4 parade showing in the absence of **Mickey Fussell** (who was out sick). She requested the equivalent of an "after-action report" to focus on "lessons learned". She cited several improvements which could be made, to be included in the critique. Under "New Business", **Bill Pittman** spoke highly of his visit to the National Museum of the Pacific in Fredericksburg, Texas, and its coverage of the "Flying Tigers" history. **Steve O'Driscoll** suggested that the Woodlands High drill team and color guard be invited to our next flag disposal ceremony. Drill team member **Sullivan** agreed to check out such possibility after school resumed. We have over 70 distressed flags for proper disposal. **Win Salter** asked about the past proposal to have a Boy Scout Troop conduct its formal flag disposal ceremony which involves cutting a flag into pieces and burning each. The Vice Commander agreed to look into such Scout Troop interest, even though an open fire could not be set at the Community Center's parking lot.

The Commander ran through incoming mail, some of which required noting, including three "thank you" letters from Boys State grads and one from "Texas Sentinel", to which the Post made a donation. Another notice was of the August 6 "Welcome Home

Family Day" for returning troops at the Houston Zoo (where volunteers are sought to man tables).

There being no further business, the Commander closed the meeting "by the numbers".



VETERAN'S ADVOCATE

BUDGET APPROVED: *By Rick Svatora, Texas Veterans Commission, Austin*

The 82nd Texas Legislature passed a budget with only a slight, two-percent decrease in funding to the Texas Veterans Commission. On June 17, 2011, Gov. Rick Perry signed the budget into law and it takes effect September 1, 2011. Due to the leadership of budget writers Sen. Steve Ogden and Rep. Jim Pitts, the Texas Veterans Commission's budget for three of its core program areas – Claims, Education, and Employment – was restored to adjusted Fiscal Years 2010-2011 levels. Under House Bill 1 as introduced, the Texas Veterans Commission faced a 20-percent cut to those programs. The restoration in General Revenue funding amounts to over \$2.5 million for the agency. The Texas Veterans Commission's success this session was due to the support of a number of legislators committed to the agency's service to veterans.

Rep. Ralph Sheffield, Vice Chairman of the House Defense and Veterans' Affairs Committee, passed an amendment on the House floor to restore the Claims budget.

Rep. John Otto, Chairman of the House Appropriations subcommittee that wrote the budget for the Texas Veterans Commission, was the first to increase funding by providing \$800,000 to the Claims budget. He also funded the Texas Veterans Commission's request for a Women Veterans Coordinator. The funding provided for the coordinator in the final budget will allow Texas to assist women Veterans to attain equitable access to services.

The Texas Veterans Commission Fund for Veterans' Assistance will also start administering the Veterans Housing Assistance Program, beginning September 1, 2011. Sen. Leticia Van de Putte, Chair of the Senate Veterans Affairs and Military Installations Committee, led the effort and worked with Sen. Tommy Williams to transfer the funding from the Texas Department of Housing and Community Affairs to the Texas Veterans Commission. The program will provide at least \$585,000 in grants per year to modify homes of injured service members, provide temporary housing for caretakers of severely injured service members, and provide rental assistance to Veterans and their families. In addition, legislators worked tirelessly to enhance and protect the Fund for Veterans' Assistance:

- Senate Bill 1635, by Sen. Wendy Davis and Rep. Joe Farias, creates an option on vehicle registration renewal forms to enable individuals to

donate directly to the Fund for Veterans' Assistance.

- Senate Bill 1739, by Sen. Davis and Rep. Joe Pickett, chair of the House Defense and Veterans' Affairs Committee, will prohibit the use of the Fund for any purpose other than grants to meet the needs of Veterans or for the administration of the Fund.

Gov. Perry signed both bills into law on June 17, 2011.

WALTER REED ARMY MEDICAL CENTER SCHEDULED TO CLOSE

After 102 years of vital service to the wounded and disabled men and women of our armed forces, as well as to governmental officials, Walter Reed Army Medical Center will close its doors next month. Walter Reed began life as a general hospital at what was in 1898 called Washington Barracks on land set aside by George Washington as a military reservation. It is the third oldest US Army installation in continuous use in the US, the older being West Point on the Hudson and Carlisle Barracks in Pennsylvania.

Located where the Potomac and Anacostia rivers join, it was an excellent site for defense of the nation's capital. The base was renamed after WWII and became Fort McNair, named for Lieutenant General Lesley J. McNair, killed in Normandy in 1944. Its hospital is perhaps one of America's most historically significant military medical treatment facilities.

Starting in 1881, Major Walter Reed, of yellow fever fame, was Camp Surgeon and later Professor of Medicine and Curator of the Army Medical Museum. In 1902, he died at the facility from complications of surgery for appendicitis. In 1901, "Walter Reed's Clinic" became an entirely separate command from Fort McNair and was relocated eight years later to a new facility on a nearby site, becoming Walter Reed General Hospital. The original facility became the post hospital until 1911 when it was converted into a clinic.

In 1923, General John J. Pershing signed a War Department order creating the "Army Medical Center" on the same campus as

Walter Reed General Hospital. Pershing lived at Walter Reed from 1944 until his death in 1948. In 1951, the Medical Center and the hospital were combined and renamed "Walter Reed Army Medical Center".

The complex today, located on 113 acres, includes about 5,500 rooms, distributed among 100 buildings. It has served more than 150,000 active and retired military personnel from all branches of the military. Today, the President, Vice President, Senators and Representatives may all receive care at the facility, which is ranked as a tertiary care center, housing numerous medical and surgical specialties. Former President Eisenhower died there in 1969 and virtually all Presidents and Vice Presidents have received care there. But the real heroes who have been treated at Walter Reed are exemplified by National Guard Sergeant John Kriesel of Minnesota and Army Sergeant Patrick Hagood of South Carolina, two of many wounded veterans visited by President George W. Bush.

In 2005, the Base Realignment and Closure Commission noted that the Department of Defense proposed replacing the complex, moving its functions to the site of the National Naval Medical Center in Bethesda, Maryland, seven miles away. The consolidation of three military hospitals, including closure of aging Walter Reed, was approved, but the name "Walter Reed" would be retained. The combined complex is to be called Walter Reed National Military Medical Center, staffed with medical personnel of all services. The estimated cost of the plan, which has been under implementation, is \$2.6 billion, over twice its original, 2005 estimate.
