## MEETING HIGHLIGHTS (December 15, 2011)

Commander Biggerstaff opened the meeting in the prescribed manner. The Commander asked the Sergeant-at-Arms Jim Bolin to introduce the visitors, who included: new member Bob Bagley (Air Force/Security 1971-1997, now with Montgomery Hospital); a member at his second meeting, who joined at the picnic, Green (retired Army Terry Command. Sergeant. Major -2009; now working with the telephone company); and longtime member, who came out for the meeting, Peter Koch (retired Navy - 1974), now head of a foundation to Teach The Constitution).

First Vice Commander Emery Heuermann reported that the Post has 291 paid-up members toward of a goal of 398 members. He also noted that the last Bugle went out to 490 Post members and friends. He also said that the Post Website was up and running at <alpost305.org>.

Chaplain **Jerry Mulvihill** reported that we have nine of the Bibles which we give out at funerals. He also reinforced his remarks made a couple of meetings ago when he asked to be notified when there were any Comrades who were sick or injured. We have appropriate cards on hand.

Historian **Win Salter** noted that the history book for this year was coming along, but he had been paying more attention lately to advancing the Cookbook Project, which will need to be funded in the next budget so the book can be published. The Project could use some more recipes.

Under "Old Business", the Commander reminded everyone that next meeting includes the Annual Chili Cook-off. All Post members are invited to submit their chili version to be judged by members of the Auxiliary.

Under "New Business", those present discussed the aborted visit to a casino. More information is needed, but it appears that it will be rescheduled in either March or April on a first Tuesday.

Under "For the Good of the Legion" it was noted that there are new Coupon/Entertainment Books for sale at \$49.95 each. This is a big fund raiser for the Post and a bargain for members and friends. The Post needs your support to buy these books or help sell them. If they seem expensive, remember they are filled with coupons worth many times the value of the book. There is certainly something for everyone in the book. Then the Post voted to donate \$100.00 to Houston's USO.

The meeting was closed in the prescribed ritual.

#### **SPEAKING OF CHILI**

When the American West was undergoing settlement, a durable trail food was devised which consisted of dried beef, suet, dried chili peppers and salt. These were pounded into bricks and allowed to dry. On the trail, frontiersmen would boil a brick in water, which resulted in a sort of hearty stew. This staple became embellished as towns developed and saloons and cafes offered variations on the original concoction, using near fresh beef, fresh or dried peppers and, in some cases, beans. During the 1880's, brightly-garbed Mexican women, known as "chili queens", began to operate from open-air stands, selling their chili by the bowl to passersby. They were a fixture around San Antonio's Military Plaza and other gathering places. The aroma was a potent sales pitch!

The 1893 Columbia Exposition in Chicago included a "San Antonio Chili Stand", which brought the dish to other parts of the country. San Antonio, with the Alamo, was a significant tourist destination and helped Texas-style chili con carne spread throughout the South and West. As early as 1904, "chili parlors" were opening outside of Texas. After working at the Louisiana Purchase Exposition, one Charles Taylor opened a chili parlor in Carlinville, Illinois, serving "Mexican Chili". In the 1920's and 1930's chains of dinerstvle chili parlors appeared throughout the Mid-west. Regional variations evolved. like that called "Cincinnati Style". In 1977, the State of Texas designated chili con carne the official dish of Texas.

In the 1885, rancher Lyman Davis of Corsicana, in partnership with

an experienced chuck-wagon cook, began producing a heavily-spiced chili, based on lean chunks beef and rendered beef suet, which he sold by the pot to local cafes. In 1921, Davis began canning his chili, naming it for his pet wolf. The earliest canned chili was produced in 1908 by Willie Gebhardt of New Braunfels, then later, San Antonio.

There is much debate as to whether beans and/or tomatoes "belong" in chili. And, it seems that every chili cook has his or her closely-held "secret recipe". Other variations include the addition of corn, tomatillos, cocoa, coffee, cola, beer, molasses, you name it!

In any case, any Post or Auxiliary member, who wants to show off his or her "secret recipe" for chili, should enter the Annual Chili Cook-off, a feature following the January Membership Meetings.

#### **HOMELESS VET INITIATIVE**

In an effort to keep veterans from turning to the streets, the Department of Veterans Affairs announced on December 5<sup>th</sup> that it will offer \$100 million in grants to local agencies that help returning troops in need. The VA estimates that 107,000 veterans are without a place to stay on any given night and has committed to eliminating the mounting problem by 2015. The VA's most recent

program will enable community agencies to apply for grants from the \$100 million fund, so that they intervene before former servicemen and servicewomen are forced to give up their homes. "The problems that lead to homelessness begin long before veterans and their families are on the streets," Secretary of Veterans Affairs Eric K. Shinseki said in a "By putting more statement. resources into prevention services for people at risk of becoming homeless, we will continue to help veterans and their families get back on their feet and turn their lives around." The program aims to help more than 35,000 veterans and families. Offering veterans training, education and counseling -- among other services -- is critical before returning troops resort to living in cardboard boxes. Homeless veterans are more likely to develop threatening diseases and remain on the streets longer -than non-veteran homeless people, according to a study conducted bν the 100.000 Homeless Campaign released in November. "Those who have served this nation as veterans should never find themselves on the streets, living without care and without hope." Shinseki said.

#### **VETERANS JOB UPDATE**

The Department of Labor has announced a new partnership with Microsoft Corporation to provide veterans with vouchers for no-cost training and certifications that can important lead to industryrecognized credentials. The voucher program will serve veterans in five communities with the highest number of returning post-9/11 era veterans: Seattle, WA; San Diego, CA; Houston, TX; Northern Virginia; and Jacksonville. FL. A similar opportunity is available through the Syracuse University's School of Information Studies. They are hosting a non-credit online curriculum free of cost to veterans who have served on active duty post 9/11/01, which preparation focuses on transition to corporate careers in information technology (IT) or operations. This program available to both employed and unemployed post-9/11 veterans with a minimum of a high school diploma and is comprised of two certificate courses: VET 1: Career Skills for Global Enterprises and Applied Technology 2: Education.
