• Be a registered, active member of a chartered Boy Scout Troop, Varsity Scout Team, or Venturing Crew, and the son or grandson of a Legionnaire or Auxiliary member.

AND

• Received the Eagle Scout Award.

• Be an active member of his religious institution and must have received the appropriate Boy Scout religious emblem.

• Have demonstrated practical citizenship in church, school, scouting, and community.

 Have reached his 15th birthday and be enrolled in high school at the time of selection.

Note: Eagle Scouts still in high school who reached their 18th birthday during the nomination year remain eligible if otherwise qualified.

> MEETING HIGHLIGHTS (January 19, 2012)

Commander Biggerstaff opened the meeting in the prescribed manner. The Commander asked the Sergeant-at-Arms about visitors, but there were none. The Commander then gave the Treasurer's report as \$17,509.71 in the General Fund, \$5,210.27 in the Money Market Fund and \$17,000.00 as a CD for a total of cash assets \$39,719.38.

First Vice Commander **Emery Heuermann** reported that the Post has 304 paid-up members toward of a goal of 398 members, for a goal reach of 74%.

Service Officer **Dayton Denton** reported that Post member **Frank Canfield**, now living in Corsicana, TX, is ill with cancer but doing well under the circumstances.

Under "Old Business", the Commander reminded everyone that next meeting includes the postponed Annual Chili Cook-off. All Post members are invited to submit their chili version to be judged by members of the Auxiliary.

Mickey Fussel reported that the Casino trip would be Tuesday. April 3rd. He advised us to make reservations with 1st Class Tours, 281-443-1200, seven days prior to the date of the trip as that date is a popular day for it is Senior Day. VA EMERGENCY CARE UPDATE

The VA announced on 12 JAN a change in regulations regarding payments for emergency care provided to eligible veterans in non-VA facilities. "This provision

helps ensure eligible veterans continue to get the emergency care they need when VA facilities are not available", said Secretary of Veterans Affairs Eric Κ. Shinseki. The new regulation extends VA's authority to pay for emergency care provided to eligible veterans at non-VA facilities until the veterans can be safely transferred to a VA medical More than 100.000 facility. veterans could be affected by the new rules, at a cost of about \$44 million annually. VA operates 121 emergency departments across the country, which provide resuscitative therapy and stabilization in life-threatening situations. They operate 24 hours a day, seven days a week. The VA also has 46 urgent care units, which provide care for patients without scheduled appointments who need immediate medical or psychiatric attention. PHARMACY COPAY UPDATE

On January 1, 2012 the Walgreens drugstore chain left the **TRICARE** Pharmacy Network. For the last several months, it has been written reported about the contractual impasse that Walgreens and Express Scripts, Inc (ESI) had reached. ESI is the pharmacy benefit manager that has the TRICARE retail pharmacy contract. If you have been using Walgreens as your drug store you should now consider transferring your prescriptions (if you have not done so all ready.) You could, of course. continue to use Walgreens. but they will then be a non-network pharmacy. Your co-pays will be much higher. Additionally, vou would be required to pay the full amount of the prescription up from and then submit a claim for reimbursement.

AN INCIDENT WELL

REMEMBERED

On February 3, 1943, the USAT Dorchester, a small troopship, was one of three ships in convoy enroute to a US airbase at Narsarssauk, Greenland. Three Coast Guard Cutters were the convoy's escorts. At about 1:00 AM, a torpedo fired by German U- boat U-223 struck the Dorchester on its starboard side near the engine room and instantly killed 100 crewmen and troops. The ship which carried 902 souls sank in less than 27 minutes, with a total loss of 672 lives. Two of the escorting cutters picked up 230 survivors.

This WWII incident would have remained just that except for the heroism of four Army lieutenants, all chaplains of differing religious affiliations. The four chaplains helped their fellow servicemen to abandon ship, guiding them to lifeboats and rafts, handing out life jackets and lastly donating their own jackets to those without. They were visible to survivors, joined together and staying with the doomed ship.

~ Survivor **John Ladd** watched the chaplains distribute life jackets, and when they ran out, they removed theirs and donated their own jackets to a few without.

~ Survivor **Pvt. William B. Bednar** recalled, "I could hear men crying, pleading, praying. I could also hear the chaplains preaching courage. Their voices were the only thing that kept me going!"

~ Survivor **Grady Clark** said, "As I swam away from the ship, I looked back. The flares had lighted everything. The bow came up high and she slid under. The last thing I saw, the four chaplains were up there praying for the safety of the men. They had done everything they could. I did not see them again. They themselves did not have a chance without their life jackets."

~ Survivor Petty Officer John J. Mahoney tried to re-enter his cabin, but Rabbi Goode stopped him. Mahoney, concerned about the cold artic air, explained he had forgotten his gloves. "Never mind", Goode responded, "I have two pairs." The rabbi then gave the petty officer his own gloves. In retrospect, Mahoney realized that Rabbi Goode was not conveniently carrying two pairs of gloves, and that the rabbi had decided not to leave the Dorchester.

These brave men of God were:

~ **George L. Fox –** Methodist Reverend of Lewistown, Pennsylvania; age 43.

~ Alexander D. Goode – Rabbi of Brooklyn, New York; age 32.

~ **Clark V. Poling** – Reformed Church Reverend of Columbus, Ohio; age 33.

~ John P. Washington – Roman Catholic Priest of Newark, New Jersey; age 35.

In July 1960, "The Four Chaplains Medal" was established by act of Congress and presented to the next of kin by the Secretary of the Army on January 18, 1961. All four chaplains had been awarded the Purple Heart and the Distinguished Service Cross posthumously in December 1944. Many memorials to the Four Chaplains exist throughout the US. Annually, American Legion Posts remember Four Chaplains' Day and conduct the Four Chaplains' Memorial service.
