I want to re-print an article that was put out by the National Adjutant concerning the National Commander's Message that was in the Legion Magazine. This is on the Department of Texas website Thursday, February 2, 2012 - 2:21pm

An error occurred in the "Commander's Message" in the February 2012 issue, and it was not the fault of the National Commander.

"Article II, Section 2 of the National Constitution was quoted correctly, as it reads today. The paragraph following that. however, reflected earlier language which has now been deleted from the National Constitution. Hence, even though it is not the best practice for a Legion official to hold public office because it is so difficult to separate motives, actions and their interpretation by others, Legionnaire may hold Legion and political office at the same time. We rearet the error."

Holdina an office organization and running political office at the same time might cause problems. It may be easier to hold the high office, and then after the tenure is complete. run for political office. Even the best intentions may be spun in a negative way, and it's difficult to know what others perceive or interpret. Just a thought..."

MEETING HIGHLIGHTS (February 16, 2012)

Prior to the meeting, the Auxiliary joined the Post as we celebrated the remembrance of the Four Chaplains. Our respective

VETERANS LEGISLATION STATUS

Support of these bills through cosponsorship by other legislators is critical if they are ever going to move through the legislative process for a floor vote to become law. A good indication on that likelihood is the number of cosponsors who have signed onto the bill. Any number of members may co-sponsor a bill in the House or 79 in the Senate. At http://thomas.loc.gov vou can review a copy of each bill's content, determine its current status, the committee it has been assigned to, and whether your legislator is a sponsor or cosponsor of it. To determine what bills and amendments your representative has sponsored, or dropped sponsored, sponsorship from. refer to http://thomas.loc.gov/bss/d111/sp onlst.html.

Grassroots lobbying is perhaps the most effective way to let your representative and senators know your opinion. Whether you are calling into a local or Washington, D.C. office; sending a letter or email; signing a petition; or making a personal visit, Members of Congress are the most receptive and open to suggestions from their constituents. The key to co-sponsorship increasing on veteran related bills. and subsequent passage into law, is letting legislators know of veteran's feelings on issues. You can reach their Washington office via the Capital Operator direct at (866)272-6622, (800)828-0498, or (866)340-9281 to express your views. TEXAS VETERANS' LICENSE PLATES

Texas offers military veterans a multitude of options to personalize

their plates. For example, if can eligible, apply you for Disabled Veteran license plates for your car, light truck or motorcycle if you are certified by the Veterans Administration to have a 50 percent service-related disability, or 40 percent due to amputation of a lower extremity. An annual \$3.00 fee is collected for the first set of plates. There is no fee to apply for an additional set of plates, but you are required to pay the regular registration fee, which can be found http://ftp.txdmv.gov/pub/txdotinfo/vtr/fees/fee chart 1c.pdf and fees. applicable information about parking privileges with Disabled Veteran plates. refer http://www.txdmv.gov/vehicles/dri vers/disabled.htm

To order DAV plates by mail go to http://www.txdot.gov/txdoteforms/GetForm?formName=/VTR-615.xdp&appID=/VTR&status=/re portError.jsp&configFile=WFServl etConfig.xml, complete the application form online, print and mail, with fee payment in the form of a personal check, money order or cashier's check, and any required attachments to your county tax office. The specialty plate fee is \$3.00 per year for one vehicle.

VA PATIENT-CENTERED CARE

By building on its unique structure and assets, the Veterans Health (VHA) Administration has leapfrogged ahead of many health systems on the path toward a patient centered care model, as concluded many health-care quality improvement experts at a recent conference. The Patient-Centeredness in Policy Practice conference [a conference evidence. programs, implications] was co-hosted by the ECRI Institute, а nonprofit organization using science-based methods to identify processes and products that improve health care. and the US Food and Drug Administration, with support from several other organizations. The meeting convened experts on a range of issues related to the implementation of a patientcentered care model-one that focuses on the person or family rather than on disease, that empowers patients to take an active role in their care, and that provides seamlessly integrated services from a multidisciplinary team. Several speakers pointed to the health system operated by the Department of Veterans US Affairs as one that has successfully transitioned toward patient-centered care. Leaders from the VHA, which administers the VA health system, also spoke about how they have embraced and implemented this approach. "Right now, the VA is used as a model of quality," said Steven E. Weinberger, MD, executive vice president and chief executive officer of the American College of Physicians. at the meetina. Malcolm Cox. MD. chief academic affiliations officer at the VHA, noted that one of the VA's key advantages is that it has an integrated health system, which mitigates some of the dysfunction that occurs in the wider health system with its many payers, providers, and institutions not working in a coordinated fashion. "The real issue that has moved the VA to [a model of quality care] is its dedication to measurement and performance improvement at individual, unit, hospital, system levels," Cox said. The VHA's shift toward a patientcentered system began early, according to a presentation by Kupersmith, MD, research and development officer at the VHA. In the 1990s, he explained, the system began to focus more on patient-centered, outpatient primary care and to harness the capabilities electronic health records to drive quality improvement efforts. The VHA's culture, which focuses on service to veterans and also emphasizes learning through affiliations with medical schools, has also been an asset in the transition, he added. "A lot of [the patient-centered care model] is about culture," said Eric Holmboe, MD, chief medical officer of the Board of American Internal Medicine."It's not just about the technical aspects."

Kupersmith also emphasized the VHA's efforts to expand veterans' access when they need and want it through Web- or telephonebased services, a network of community-based clinics, secure e-mail access to the care team. and scheduling services. For example. he highlighted MyHealthVet, Web-based а platform that enables veterans to access their health information, share it with caregivers or family members, complete health risk assessments, get 25 prevention reminders, refill medications, and e-mail their clinicians. Additionally, the VHA has begun developing a suite of smartphone apps that allow veterans to track their symptoms, access advice, and support their health-care decision making.

The VA system's high level of integration was also emphasized. Among the system's features are the co-location of specialty and primary care providers, collaborative care models. involving teams of multidisciplinary clinicians and support staff, electronic decision support for clinicians. and care coordinators who provide central contact for veterans.

Winning CHILI Tidbits

- Try mixing beef and bison for a low fat chili. Brown the meat with garlic/onion powders and white pepper for a spicy start. Add green pepper and onions to the meat sauté as well.
- Use tomato puree and diced tomatoes for thicker chili
- Add a bit of sugar to cut the acid of the tomato.
- Use plenty of chili powder, some cayenne, fresh oregano and plenty of cumin.
- Dark red kidney beans give extra color to the mix. Don't be afraid to use jalapenos.
