MEETING HIGHLIGHTS
(April 19, 2012)

Commander Biggerstaff opened the meeting in the prescribed manner. The Commander then recessed the meeting to allow three candidates for local offices to outline their platforms, limited to five minutes each. Those present were **Kenny Speight** (County Commissioner), **James Noack**

(County Commissioner) and **Jay Mac Sanders** (Township Board). After reconvening the meeting, the Commander called for approval of the minutes of the Executive Committee and Membership meetings, and it was done. Discussion followed about how to inform the members as to the coming election and the nominated slate of officers. This was resolved by vote of members to send such notice by email, to those who can receive email, and by snail mail to all other members.

The Commander then asked Sergeant-at-Arms **Bolin** about visitors present. Given the number of visitors, they were asked to stand and introduce themselves. Included were new Post members **LeRoy Lueder** and **Alvin Critten**.

On membership, the Commander reported that the Post includes 326 paid-up members of a goal of 398, or a percentage of 82. There are only two months left to get dues from the 72 members. The First Vice **Heuermann** is working on calling members who have not yet renewed.

Chaplain **Jerry Mulvihill** reported that **Dutch Dettinger** has finished with treatments and is waiting for results. He is, however feeling pretty good. **Win Salter** has endured a third chemo cycle, and a CT scan is scheduled to assess the effects. Our thoughts and prayers go with our comrades.

Under "Old Business", **Jim Bolin** reported that the Birdies for Charity netted \$1,090 for the Post and \$900 for the Auxiliary. There were no winners among us however. Jim also reported that the Rummage Sale gross was \$902.57, the lowest in many years! The Post voted to donate \$90.25 to the Auxiliary in

appreciation of its help with the Rummage Sale.

The Commander was pleased to announce that the Post will be sending 15 boys to Boys State, up from last year's 12. The Post then voted to purchase a Surety Bond for three years affording up to \$25,000 in protection at a cost of \$284.

Under "New Business", **Jim Bolin**, Chair of the Nominating Committee, presented the slate for officers during the 2012-2013 year. (Refer to positions and names in box below.) Nominations will be opened up again at the next meeting for any member who wants to name an alternative candidate or stand for election in any position. Election will occur after all nominations are closed.

Mickey Fussell informed the members that he is planning another casino daytrip for Tuesday, July 24th; this one to L'auberge Casino Resort in Lake Charles. The bus departs from the First Class Tours site on FM1960, east of I-45 at 9:00AM. Cost is \$16.00 per gambler, but the senior perks are either \$5.00 in coins or \$10.00 meal voucher. Bus riders must make reservations seven days in advance by

The Commander noted that Post and Auxiliary came in third at the recent District 7 contest to collect white tube socks to send to VA hospitals.

Commander **Biggerstaff** asked District Commander (and Post member) **Everett Ison** to discuss the proposed redistricting of the Department's 22 districts to take into consideration the state population changes which have occurred since the last such event. Ison indicated the outcome should have little effect on Post 305; whatever option is recommended by the DEC and approved at the Department Convention.

No topics were offered "For the Good of the Legion", thus the meeting was closed in the prescribed manner.

SCAMS, SPOOFS OR ID THEFT

There are phony emails being sent to individuals, including military members, military retirees and civilian employees which appear to be sent from a Defense Finance & Accounting Service (DFAS) site. In fact, these emails are from a non-government email account despite the “dot/mil” address. The topic of such email indicates that veterans receiving disability compensation from the VA may be able to obtain additional funds the Internal Revenue Service (IRS). If you are sent such notice and comply with its directions you are likely to experience financial loss. Never sent your personal info or copies of a VA award letter, tax returns, 1099's, RAS statements or Form DD-214 to the fake DFAS address. The “retired colonel” at the Florida address is scamming you, spoofing or worse.

ANOTHER DFAS SCAM

A letter is making the circuit purporting to be from DFAS asking military members fiancées to register in its system entitling them to benefits in the event of the GI's death, and all for only a \$350 fee. Bottom Line: It's not true. It's not a DFAS letter. It's a scam.

MORE BAD GUYS

Washington (AP) – For all you computer users, a few mouse

clicks could mean the difference between staying online and losing Internet connections this summer. International hackers ran an online advertising scam designed to take control of infected computers worldwide. The FBI, in a highly unusual response, set up a safety net months ago using government computers to prevent Internet disruptions for infected users. That system, about which the users were unaware, will be shut down on July 9th. Most hacker victims did not know their PC's were infected, although the malware slowed their websurfing and disabled their antivirus software, making the computers more vulnerable to other problems. When the FBI-run servers are unplugged, any computer still using that bridge will be disconnected from the Internet. The FBI is encouraging users to visit a website run by its security partner at <http://www.dcwg.org> that will inform the user whether he is infected and explain how to fix the problem. Do this before it is too late!

BIG TRICARE PHARMACY

No scam here! The Express Scripts Holding Company of St. Louis, which handles TRICARE home delivery meds accounts, announced on April 2, that it has completed its acquisition of MEDCO Health Solutions, a related pharmacy business, following an eighth-month review by the FTC, which endorsed the merger. The new company will be called “Express Scripts Holding Company” and will be the largest pharmacy benefits manager in the US, filling a combined 1.4 billion prescriptions a year.

TRIAP PROGRAM CANCELLED

The online behavioral health counseling service known as the TRICARE Assistance Program

(TRIAP) ended on March 31. DOD officials cited “lack of use” as the principal reason behind the decision to end the program. Military OneSource offers a broad range of similar services. It can be reached by phone at 1(800) 342-9657.

JOBLESS VETS STATS UP

Unemployment among recent veterans ticked up in March, a month after hitting its lowest point in nearly four years. A Bureau of Labor Statistics report shows 10.3% of post-9/11-era veterans were jobless in March, up from 7.6% in February. For all veterans, the unemployment rate increased only slightly to 7.5% from 7.0%.

'NAM VETS TO BE HONORED

Per the National Announcement and Proclamation Ceremony for the Commemoration of the 50th Anniversary of the Vietnam War, the DOD will host such ceremony at the Vietnam Memorial (“The Wall”) in Washington, D.C. on May 28th. The event will thank and honor those who served in the Vietnam War. This is the first of many celebrations over the next few years honoring our Vietnam veterans.

Identity theft is one of the fastest growing crimes in the US. If you suspect you have been a victim of identity theft, take these steps:

~ Contact the fraud department of any of the three consumer reporting companies (below) to place a fraud alert on your credit record. You need to contact only one of these credit watchdogs.

~ Close out bank and/or credit card accounts that you know or suspect have been tampered with or opened fraudulently.

~ File a report with your local police department.

~ File your complaint with the Federal Trade Commission (FTC).

May 18-20, 2012: Second Division Convention: Delegates selected from the Posts of the Second Division meet in Beaumont to elect a new Division Commander for the year 2012-2013. June 21, 2012: Officers' Installation Ceremony: The officers elected at the May meeting will be formally installed into their respective offices for the 2012-2013 year. This installation takes place near the close of the June Membership Meeting, and the first meeting where the new officers preside is the July meeting.

July 11 to 15, 2012: Department Convention: For the first time in a long time, the Department Convention will be held in Houston. This is the perfect time to attend your first Department Convention without having to pay for lodgings and travel many miles to get there. July 19, 2012: New Officers Take Over: At the July meeting, the newly elected officers will run the meeting and carry out all the needed administrative actions to kick off the year, including the Commander's selection of new and ongoing programs to be funded and carried out, naming of Standing and Special committees and the appointment of chairpersons, at least. EARLY AMERICAN FLAGS

Before there were the “stars and stripes” of Betsy Ross fame or the “red, white and blue”, Americans saw need for other flags, particularly during times of conflict, including the Revolution and events leading to that break with England. A few of these banners are being used today to demonstrate some point; others are little known to the average American. This article is not comprehensive, but it cites and depicts the more commonly seen flags and a couple less well known.

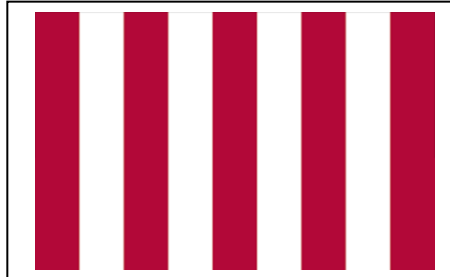
THE GADSTEN FLAG – In 1775, the United States Navy was established to intercept British ships carrying supplies to British troops in the colonies. The Second Continental Congress authorized the mustering of five companies of Marines to accompany the Navy on its first mission. The first Marines that enlisted were from Philadelphia, and they carried drums painted yellow, depicting a coiled rattlesnake with 13 rattles and the motto, “Don’t Tread On Me”. In Congress, representing



South Carolina, Continental Army Colonel Christopher Gadsden was one of the members of the Marine Committee charged with outfitting the Navy. Before the naval force left port, the newly-appointed commander, Commodore Esek Hopkins, was given a yellow rattlesnake flag as his personal standard.

SONS OF LIBERTY FLAG – As protests against British rule grew within the colonies prior to the Revolution, citizens banded together into “Sons of Liberty” societies. They would typically meet under some large tree and would erect “liberty poles” as a symbol of defiance. In 1765, in Boston, a flag was flown to

protest colonial treatment, and it became known as the “Sons Of Liberty Flag”. It consisted of nine vertical stripes – five red and four white, representing the nine colonies protesting the Stamp Act of 1765. (The other four colonies were in support but, due to the short notice given, their agreement was late.)



Later, the symbolism of “9” came to apply to the nine states represented at the adoption of the Constitution in 1797, and the nine states which ratified it into existence. In another version of the Sons of Liberty flag, 13 horizontal stripes, alternating red and white, were displayed.

FIRST NAVY JACK FLAG – The U. S. Navy adopted the rattlesnake as its icon of strength and courage and the unity of the American states. Individually, the rattles of the snake have no sound, but once joined can be heard by all. While it does not strike unless threatened, once provoked, the deadly rattlesnake never surrenders. Thus, the Navy’s first shipboard jack was a flag with horizontal red and white stripes, with



a yellow rattlesnake superimposed and the motto, “Don’t Tread On Me” across the lowest white stripe.

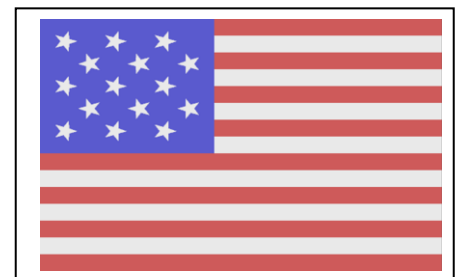
VETERAN EXEMPTS FLAG – Veterans of the Revolution from upstate New York and the Ohio territory were deemed exempt from additional military service, and many had been compensated by grants of

land on the frontiers. They organized themselves as the “Veteran Exempts” and enabled the younger militia to go off to war while the older men stayed at home to protect the settlements. Veteran Exempts were mobilized during the War of 1812 and fought in the Battle of Plattsburgh, New York. The Veteran Exempts flew a flag with a black ground with 13 silver stars on a white canton. In the center of the



flag was a skull and crossbones surmounted by a coiled rattlesnake. Wreaths above and below carried the mottos “Don’t Tread On Me” and “They Will Be Done”.

FORT McHENRY FLAG – Fort McHenry, guarding Baltimore harbor and the site of the Battle of 1814 which gave birth to our national anthem, flew a flag which was commissioned by the Fort’s commander, Major George Armistead. It displayed 15 white stars on a blue field and 15 stripes, alternating red and white. The design was similar to the 15-star flag, adopted as the national standard in 1795 and prevailed to 1818. The 15 stars and stripes reflected the statehood of Kentucky and Vermont, the next two



states admitted following the original 13. In 1818, Congress proclaimed that each new state would add a star to the flag, but the stripes would revert to the original 13.

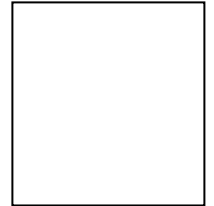
