Dear Legionnaires,
I would like to thank everyone who attended our July 19th meeting at the South County Community Center in the Woodlands. I really look forward to working with everyone in promoting the American Legion and what it stands for in the United States of America and Texas in particular.

We shared information concerning the steady decline in membership within the American Legion and what we, as a Post, can do to turn this around. One subject that was brought up was that we are now losing many of our World War II veterans to the Post Everlasting as they age and most of our members are now of the Vietnam Era. This means that we have to start to reach out to the veterans of the recent conflicts to fill these

places. In the next few weeks, we will be forming a Committee to analyze the situation at Post 305 and come up with a plan to advance the membership within the Legion and within our Post. We will announce the program at the August Post meeting, as it will take each and everyone one of us to accomplish this worthwhile task, and I know you are all up to the challenge.

We are also revisiting our Committees such as the following: Oratorical Contest, Boys State, Scholarship, Flag Etiquette, Flag Disposal, Funerals, Color Guard, Membership, Fund Raising, Veterans Affairs & Rehabilitation, Public Relations, Children & Youth, Legislative, POW/MIA, Employment, Boy Scouts and Community Service. We will be asking for volunteers to help us on these committees, so if you would like to assist in any one of these programs, just let us know and we will place you on the list. If you should require further information concerning a particular committee prior to committing, please contact us, and we will send you a detailed definition and purpose of the committee in question.

The Post is in the final stages of reviewing the Post Constitution and By-Laws to assure we are in compliance with the Department and National Constitution and By-

Laws. In performing the review, it has been decided to re-energize our American Legion Riders Program. We will also add two more officer positions to our Post. They will be Assistant Chaplain and Assistant Sergeant-at-Arms. When the review has been completed, it will be submitted to the membership prior to final submission to the Department of Texas.

During the Department Convention in Houston, this month, Post 305 was awarded second place for our Website. All thanks go to our Post 305 WebMaster and **First Vice Commander Emery Heuermann**. District 7, of which we are a member, placed in the top 10 Districts within the State of Texas. Post 305 **Past Commander Kimberly Biggerstaff** was awarded the honor of representing the District at the National Convention in Indianapolis in August of this year.

I would like to remind everyone that our annual picnic is rapidly approaching. The date is Thursday, October 18th and it will be held at Shadowbend Park on Lake Woodlands Drive. This is a great time to relax and enjoy the comradeship with each other. Hamburgers, hot dogs and bratwurst will be provided by the Post. More details will be disseminated next month.

MEETING HIGHLIGHTS
(July 19, 2012)

Commander Koch opened the meeting in the prescribed manner. After approval of the previous meeting's minutes, the Commander then asked **Sergeant-at-Arms Jim Bolin** about visitors present. **Brian Claypool**, a veteran of the Vietnam War, introduced himself. The Commander moved on to call on **Kim Biggerstaff**, the Finance Officer, to give the Finance Report. She reported that the General Fund contained \$16,756.19, while the Allocated Fund total was \$22,360.65 for a Total Assets of \$39,117.27.

On membership, the **First Vice Commander Emery Heuermann** noted that it was early in the year and statistics on membership were not yet available. He did report that our goal for the new year was 333, which is 1% higher than our achieved membership last year..

Our **Sergeant-at-Arms Jim Bolin** had no report. Our Comrade in Distress, **Win Salter**, is doing better and expects to be back around Veterans Day. **Service Officer Dayton Denton** is away until September. **Second Vice Commander Mickey Fussell** reported on the 4th of July parade, declaring it a success as we had all the seats filled on the float. He also noted that the projected trip to the L'Auberge Casino Resort on the 24th of July was next

Tuesday and it was time to call and reserve a seat on the bus if you were inclined to go.

Under Unfinished Business, we were reminded of the farewell get-together for **Sue Ellen** and **George Bannon** on Saturday evening at the **Bolin's. Pickens Jones** reported that he still has Entertainment Books for sale.

COLA 2013 UPDATE

Veterans will receive a cost-of-living adjustment (COLA) increase in their disability benefits if the bill passed July 9 by the House receives the same treatment in the Senate. The Veterans' Compensation Cost-of-Living-Adjustment Act of 2012 passed the House on a voice vote. It would provide a cost-of-living boost equal to that given to Social Security recipients. Rep. Jon Runyan (R-NJ) introduced the bill. After it passed, he said, "Congress knows that veterans are dependent upon us acting in a timely manner with regards to their needs. By acting on the yearly COLA this summer instead of waiting until the last minute, we tell America's veterans that we remain dedicated to ensuring that they are given the benefits they were promised when they signed up to serve." If passed by the Senate and signed by the President, the law will go into effect December 1. A press release from the House Committee on Veterans' Affairs estimates the COLA for this year will be approximately 1.9 percent. Runyan has also introduced the American Heroes COLA Act, which would put in place a permanent COLA like that for Social Security recipients. That legislation has been passed out of the Veterans' Affairs Committee and is awaiting vote by the full

MILITARY FUNERAL HONORS

At all military funerals, a military honor detail should be present. This detail should consist of at least two active members of the Armed Forces. One of these members should belong to the same branch of the military as the deceased. This detail, though, can consist of many more people. They can be active or retired members of the military and/or members of veterans organizations. The military honor detail should fold the flag of the United States. The flag is then presented to the deceased veteran's next of kin. If a next of kin is not present, the flag is given to a close friend or associate. The flag is usually presented by a military chaplain at the end of the funeral. Taps should be played at all military funerals. If possible, this composition should be performed by a bugler in the military. However, if such a bugler is not available, taps may be played by a civilian musician or by an audio recording. Taps is usually performed at the conclusion of a funeral. According to the National Defense Authorization Act, the Department of Defense is required, if requested, to provide the above-mentioned honors for the funerals of veterans.

Some military funerals have a firing party that fires a three-volley salute over the grave. (In the Navy, a cannon is fired.) Many confuse the firing of three volleys by riflemen at military funerals with a 21-gun salute. This is not a 21-gun salute, however. The origin and significance of the military custom of firing rifle volleys at funerals is interesting. During the funeral rites of the Roman Army, the casting of the

earth three times upon the coffin constituted the burial. It was customary among the Romans to call the dead three times by name, which ended the funeral ceremony. As friends and relatives of the deceased Roman departed, they said "Vale", or farewell, three times. Over time, when firearms were introduced on the battlefield, the custom of firing volleys was established to halt the fighting to remove the dead from the battlefield. Once each army had cleared its dead, both sides would fire three volleys to indicate that the dead had been cared for and that they were ready to go back to the fight.


EVENT BULLETIN BOARD
