





MEETING HIGHLIGHTS

June 20, 2013

Prior to the Meeting, the Post conducted a Flag Disposal Ceremony to honor those flags which have become faded and worn as they flew over the graves of our departed comrades and various public places. Officiating was **Ed Jarvis, District 7 Commander**, with non-participating members of the Post and Auxiliary were in attendance.



The Post Membership Meeting was convened at 7:00 PM in the prescribed manner and a quorum was determined. Minutes of last month's meeting were distributed, read and approved by motion and vote. **Finance Officer Kim Biggerstaff** had handed out her monthly financial report and a budget update. The General Fund totaled \$14,640.98 at the beginning of May and the Allocated and Money Market funds held \$22,880.97, for a total

bankroll of \$37,521.95. The Commander then awarded **Kim** the plaque that attests to her selection as 2013 Legionnaire-of-the-Year.



Second Vice Commander Mickey Fussell reported on preparations for the Fourth-of-July, including decorating the float. He stated that the float would seat 19 folks, and he urged that all seats be filled. **Sergeant-at-Arms Jim Bolin** moved that the Post donate 10% of the Rummage Sale net profit to the Auxiliary. The motion was passed by voice vote. **First Vice Commander Emery Heuermann** moved that further business be postponed so that the newly elected officers could be installed. **District 7 Commander Ed Jarvis** performed the installation with the help of **District 7 Chaplain Joe Piazza** and **Assistant Sergeant-at-Arms Sheila Schulte**. PROGRESS ON CURRENT PROGRAMS

May Match Madness: The offer by a few anonymous members to doubly match any un-earmarked donation to the Post made in May produced a total of \$1,950 for the Post and \$975 for the Auxiliary. The opportunity could have produced more, but-----.

Boys State Program: The week-long Boys State opportunity saw 12 high school juniors sponsored by the Post. The schools represented were The Woodlands, Oak Ridge, John Cooper and College Park. **Service Officer Dayton Denton** reported that it was a great success.

Debakay Medical Center Care Drive: The drive to collect donations of personal-care items for the wounded or sick veterans at the VA hospital continues under the direction of **Dayton Denton** with **Steve McKinsey** as the Scrounger-Expediter. This drive got off to a great start but has slipped some from attention. So, you all are reminded to bring to any meeting those new items which you think will be welcome at the hospital.

AFFORDABLE CARE ACT CREEPS AHEAD

The Affordable Care Act, also known as Obamacare, requires everyone to purchase health insurance by January 1, 2014, or pay a penalty, but a new survey indicates that many of the uninsured still aren't sure about getting coverage. The website <InsuranceQuotes.com> released the survey, which initially included 1,001

adults, 134 of whom were uninsured. They interviewed an additional 152 uninsured adults to get better data. Among the uninsured, 64 percent said they had not yet decided to purchase insurance, 19 percent planned to acquire coverage by the deadline, and 10 percent planned to simply pay the penalty for not buying it. That penalty starts small, but gets bigger over time, the site says: In 2014 [the penalty] is the greater of \$95 or 1 percent of income for an adult. For children under 18, the penalty is half the adult amount. The penalty increases each year, up to the greater of \$695 or 2.5 per cent of household income for an adult in 2016. And, a family would pay a maximum of the greater of \$2,085 or 2.5 per cent of income then, according to the Kaiser Family Foundation. Here are some additional findings from the survey:

~ 61 per cent of the uninsured said they don't have health insurance because they can't afford it.

~ 58 per cent aren't sure if they qualify for tax credits that will lower their insurance costs under Obamacare.

~ 68 per cent of those with incomes under \$30,000 a year are not sure of their eligibility.

~ 61 percent of Americans believe Obamacare will increase the cost of health care.

Tax credits will be available to households with incomes between 100 percent and 400 percent of the federal poverty level, Healthcare.gov says. That is currently \$45,960 for an individual or \$94,200 for a family of four, Families USA says. You can estimate the size of your potential tax credit with the Kaiser Family Foundation subsidy calculator at <http://kff.org/interactive/subsidy-calculator/>. For an individual making \$30,000 a year, Kaiser says minimum coverage would cost about \$1,964 per year after a \$538 tax credit — working out to a monthly payment of about \$165. (Although it's worth noting that someone with minimum coverage would face higher out-of-pocket costs.)

UPDATE ON DoD BENEFITS CUTS

The benefits that lured so many troops into military service may not remain intact after sequestration and other budget cuts, the Pentagon chief said on May 30th. The military is considering cutting retirement benefits and charging more for healthcare and prescription drugs, said Defense Secretary Chuck Hagel while speaking to troops at Joint Base Pearl Harbor-Hickam, Hawaii. Hagel was on the island as a part of his tour of the Pacific region, and solicited questions from the audience of troops based there. The Department's most recent budget proposal to Congress included increasing co-pays for prescription medication and fees for Tricare, the military's health care system. "We are reviewing every component of our budget, and we have to look at personnel costs because they represent the biggest part," he said on Thursday. "We are looking at everything across the board, [such as] entitlement programs, in every way."

Cutting these benefits will have a crippling effect on maintaining a strong military force, according to one advocacy group. "The DoD only has two carrots to entice somebody to stay 20, 30, 40 years in uniform, and that is the immediate receipt of military retirement pay, and reasonably inexpensive health care for themselves and their spouse for the rest of their lives," says Joe Davis, national spokesman for the VFW. Troops deserve subsidized benefits due to the taxing tempo of military life, he says. Constant relocation hampers earning equity on a purchased home, and precludes

military spouses from developing a steady career. Service members reentering the workforce after decades in the military have less of an edge over younger civilians applying for the same jobs, he says. Raising these costs will take a toll on the military leadership at both the enlisted and officer levels. "The impact is not so much recruitment, but it will impact retention," he says. "What you could have in the end isn't the best qualified, it's the last person standing."

Personnel funds take up over 30 percent of the Pentagon budget - at almost \$142 billion - according to the most recent Pentagon budget. That portion should receive a higher priority, Hagel said, offering a line he has repeated since sequestration and the resulting furloughs first began: "You take care of your people." "We still have the best benefits that I'm aware of anywhere in the world," he said. "We have to do things like that, or we won't be able to sustain the programs." Hagel's comments come at a time when the Pentagon is still trying to meet budget cuts, and announced it would furlough civilian employees for 11 days starting in July as a part of the across-the-board cuts known as sequestration. The U.S. government coffers are strained to accommodate a growing number of veterans coming home from war zones who require medical assistance. [Source: U.S. News & World Report]

THESE ORDERS OF GENERAL THOMAS GAGE TOUCHED OFF THE AMERICAN REVOLUTION AND LED TO OUR INDEPENDENCE DAY

In the decade following the end of the French and Indian War, the Crown set out to offset the cost of that war by levying a series of acts to extract monies from the American colonies (e.g. The Sugar Act, The Stamp Act, The Townshend Acts). Such taxation without representation at Parliament became fiercely resented, especially in the Massachusetts

Bay Colony. Over time, rebellious events occurred or were planned, such as the Boston Massacre (1770) and The Boston Tea Party (1773) and rebellion was preached by several prominent colonists (Samuel Adams, John Hancock, Paul Revere, Reverend Jonas Clark, Dr. Joseph Warren). By 1775, steps toward opposing the British were in progress. War materiel had been concentrated in the towns of Concord and Worcester from local village arsenals, and farmers and their wives purchased and pilfered

flintlocks from British soldiers and storehouses, smuggling them out of Boston. Finally, General Gage decided to capture or destroy these munitions and quell any budding insurrection. His plan for April 19th was the most closely guarded secret in Boston, and the most loosely kept. The activity of assemblage of his troops from billets in private homes made the planned sortie obvious. Warnings of the coming of British regulars went forth, and Minutemen were waiting on Lexington Green and down the road in Concord.

Boston, April 18, 1775

*Lieu Coll Smith, 10th Regiment foot
Sir*

Having received Intelligence, that a Quantity of Ammunition, Provisions, Artillery, Tents and small Arms, having been collected at Concord, for the Avowed Purpose of raising and supporting a Rebellion against His Majesty, you will March with your Corps of Grenadiers and light Infantry, put under your Command, with the utmost expedition and secrecy to Concord, where you will seize and destroy all the Artillery, Ammunition, Provisions, Tents, Small Arms and Military Stores whatever. But you will take care that the Soldiers do not plunder the Inhabitants, or hurt private property.

You have a draught of Concord, on which is marked, the Houses, Barns,, &c. which contain the Military Stores. You will order a Trunion to be knocked off each Gun, but if its found impractical on any, they must be spiked, and the carriages destroyed. The Powder and flower, must be shook out of the Barrells into the River, the Tents burnt, Pork or Beef destroyed in the best way you can devise. And the Men may put Balls and lead in their pockets, throwing them by degrees into Ponds, Ditches, &c., but no Quantity together, so that they may be recovered afterwards.

If you meet with any Brass Artillery, you will order their Muzzles to be beat in so as to render them useless.

You will observe by the Draught that it will be necessary to secure the two Bridges as soon as possible, you will therefore order a party of the best Marchers, to go on with expedition for that purpose.

A small party on horseback is ordered out to stop all advice of your March getting to Concord before you, and a small number of Artillery to go out in Chaises to wait for you on the road, with Siege Hammers, Spikes, &c.

You will open your business, and return with the Troops, as soon as possible, which I must leave to your own Judgement and Discretion. I am,


MEET YOUR OFFICERS
