Dear Legionnaires:

Post and Unit delegates have been selected, but any member in good standing may attend. This is a good chance to learn what goes on behind the scenes and to pick up on the Department's focus and goals for 2015 – which I predict will feature "membership" and "training".

### MEETING HIGHLIGHTS

(May 15, 2014)

Prior to the meeting, **JoAnne Crawford**, the lead volunteer at DeBakey VA Medical Center, spoke to the combined Post and Auxiliary. She thanks us for sending her over 600 baseball caps. She also made clear that the VA hospital does not furnish any personal items for its patients, so the ones we send are much appreciated. Our representative to the hospital is **Steve McKinney**, and the Post honored him with a Certificate of Appreciation, while Mrs. Crawford looked on.

The Post Membership Meeting was convened at 7:35 p.m. in the prescribed manner and a quorum was determined. **Commander Pete Koch**, conducted a Drape the Charter Ceremony in reflection of the passing of Post member John Nanninga.

The minutes of the last Post and Executive Committee meetings were approved, the latter containing a motion to let the Certificate of Deposit pay out when due on June 30, 2014, and the funds there be transferred to a new investment account to be set up. Temporarily, those monies are to be held as cash until an investment can be agreed. **Kim Biggerstaff, Finance Officer**, gave the Financial Report summary, as follows: General Fund Total: \$16,355.69; Allocated Fund: \$22,886.45; giving a total of \$39,242.14. The reason for the large transactions this month is because we paid for Boys State and for the liability insurance premium and received money from Boy's State donations, the rummage sale and the rifle raffle.

Next, **First Vice Commander Emery Heuermann** concluded the election cycle by first confirming there were no competing challenges to the slate of candidates developed at the last meeting. The only change, an addition, was that **Emery Heuermann** decided to run for the open At-Large position and won. Everett Ison moved that the Adjutant cast one vote for all unopposed officers for 2014-2015, and with that the election was concluded.

**Second Vice Commander, Mickey Fussell** has scheduled a trip to Coshatta Casino Resort for Wednesday, June 11<sup>th</sup>. He reminded everyone that the bus leaves at 8:00 AM from the terminal of First Class Tours off of FM 1960 E. Reservations for the trip are required and must be made at least seven days in advance. He also reported that every-

thing was falling into place for the 4<sup>th</sup> of July Parade. He pleaded for a greater turnout and more riders for the float. All members of the Post and Unit are to be at the First Methodist Church by 9:00 AM on the Fourth for an invigorating ride on the trailer.

**Chaplain Victoria Glover** reminded the membership that a memorial ceremony for John Nanninga will take place on May 20th at 1:30 PM at The Woodlands Town Green Park. **Service Officer Dayton** stated that **Joe Hammond** has been having regular hospital appointments at Memorial Herman and **Emery Heuermann** has been driving him to them. He is also trying to get a package together to distribute at the Chamber meeting which would solicit support from the members in the form of non-cash donations to veterans at the VA hospital. He asked that the present Post members join him or get some other members to come with him to the next meeting. Kim Biggerstaff reported on the Leadership Training that will be conducted in Killeen on July 19-20.

Under New Business, **Emery Heuermann** made a motion to support **Kim Biggerstaff's** representing the Post at the Department Convention with \$200 to help defray expenses. The motion carried. **Jim Bolin** made a motion that the Post give the Auxiliary 15% of the net profit from the Rummage Sale. The motion carried.

There being no further business to come before the Membership Meeting, it was closed in the prescribed manner. The membership then moved on to the eating area to partake of self-

made taco salads, followed by a large selection of desserts.



## VETERAN'S ADVOCATE

### THE VA HOSPITAL SCANDAL

Bugle readers might expect that this column would blast the VA and its medical care administrators for the utterly shocking revelations of late. But, if you have access to a TV or a newspaper, you are well aware of what has happened and what our CIC is going to do to immediately correct the problem! So, we are not going to compete with CNN or ABC or FOX here. We are offering some stories by others below.

### VFW SEEKS YOUR VA EXPERIENCE

The VFW wants VA-enrolled veterans to call the toll-free 1-800-VFW-1899 telephone line and tell them if your VA medical facility is properly serving you. According to VFW National Commander Bill Thien, recent allegations about improper care in Arizona, Colorado, Texas and elsewhere has made it difficult to separate truth from conjecture. "Veterans die every day, but veterans dying due to wrong diagnoses, unsterilized equipment or while awaiting treatment is a failure of leadership and management both in Washington and out in the field," he said. "We need to hear real life stories, good or bad, not hearsay. Only then can

we hold VA officials properly accountable for their actions or inactions." The toll-free number was rolled out in 1996 as the VA was transforming from primarily a hospital-based system into an integrated healthcare system that now includes 820 outpatient clinics that serve veterans closer to where they actually reside. ### RETIREE APPRECIATION DAYS

Retiree Appreciation Days (RADs) are designed with you in mind. They're a great source of the latest information for retirees and family members in your area. RADs vary from military installation to installation, but, in general, they provide an opportunity to renew acquaintances, listen to guest speakers, renew ID Cards, get medical checkups, and various other services. Some RADs include special events such as dinners or golf tournaments. Due to budget constraints, some RADs may be cancelled or rescheduled. Also, scheduled appearances of DFAS representatives may not be possible. If you plan to travel long distances to attend a RAD, before leaving home, call the sponsoring Retirement Services Officer (RSO) to ensure the RAD will held as scheduled and, if applicable, whether or not DFAS representatives will be available. **MARINE CORPS SERGEANT MAJOR SAYS "SUCK IT UP!"**

Top military leaders routinely say that rank-and-file troops won't mind too much if their pay and benefits are cut. The most stunning example came when the Marine Corps' senior enlisted leader recently testified before Congress that troops actually might welcome reduced compensation. "They don't want an easy life," Sergeant Major of the Marine Corps Mike Barrett told lawmakers at an April 9th hearing. "They want to be tougher people." Speculation about what troops really want or think about pay and benefits may end soon as experts mount a first-of-its-kind, force-wide survey gauging service members' views about their compensation. By the end of May, hundreds of thousands of active-duty troops, reservists and retirees will receive email invitations to take a survey launched by the Military Compensation and Retirement Modernization Commission, which Congress convened last year to tackle the thorny issues involved in the Pentagon's efforts to reduce its personnel costs.

Military leaders are looking for ways to do that without harming recruitment and retention. The top brass say personnel costs are growing at an unsustainable rate after years of generous pay raises and other perks that Congress bestowed on the force while it was fighting two long wars. In March, the Pentagon proposed cost-saving measures that included capping troops' pay raises, scaling back housing allowances, launching new Tricare fees and eliminating commissary subsidies at most domestic installations, which

would raise prices in the stores. The survey aims to identify which pays and benefits are most valued by service members. It may also identify benefits that are inefficient because their cost to the government exceeds their perceived value by troops. "To truly understand the service members' preferences and priorities with regard to compensation will allow us to make decisions that will protect the quality of life of the service members," said Jamie Graybeal, a spokesman for the Commission. "As a result of this survey, we will be able to understand not simply whether or not service members want more pay, but how the various elements of the compensation package relate to each other, which ones are valued more, which ones are valued less," Graybeal said. ### **WHAT ~ WHEN ~ WHERE**

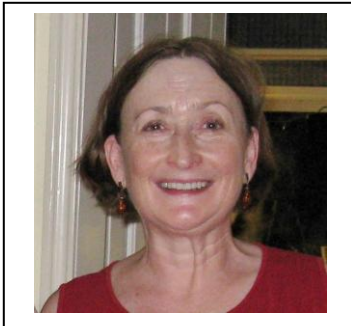
