## **COMMANDER'S CORNER**

Dear Legionnaires:

I would like to thank you all again for the vote of confidence in me that you demonstrated by re-electing me as your Commander for the 2014-2015 year. As we move ahead into a new year, there are several challenges before us. Those which I consider most important – some critical, are described and explained here. They are not all we need to deal with, but the ones which need first attention.

**Vacancies**: As you know, the Nominating Committee could not find eligible candidates to stand for election to be First Vice Commander and Sergeant -at-Arms in the month's time allotted. The officers who had those jobs last year, wanted a different role and were elected to other positions. I extended the task of the Committee past election day, but to no avail. Despite the job descriptions which were printed and recited

at several meetings, no one was attracted to run for either job. According to our Constitution, when a vacancy occurs due to any cause, the Executive Committee must appoint, on an interim basis, a member to fill such vacancy, until an election can be held to name a permanent officer. I expect the Executive Committee to conform to this stipulation, but that still leaves the issue unresolved. Please give offering services thought vour а between now and our August meeting. If you have interest or questions, call Emery Heuermann at (281)362-8431 and make known your interest. The past officers are still around and will work with you to get you familiar with the position. This is an urgent matter.

Compounding the problem, has been the recent resignation of Mickey Fussell as Second Vice Commander. Mickey. through last year, became so disappointed by the poor response to the several outings he set up and the lack of suggestions, felt he was not the man for the job - essentially the "morale officer" of the Post. Despite managing the annual transformation of the low-boy trailer. and winnina "Best Patriotic Entry" (plus the \$250 prize) in the parade, Mickey decided to pass the baton to another. So, we are now facing filling three positions!

Membership: Last year, our paid-up goal was 322 members, which we missed by just four members, ending the year at 318 "in good standing". Well, we have been given the same goal this year - 322. Maintaining and increasing membership are prime responsibilities of First Vice, one of the vacant positions. Beyond doing a bit better than last year, we must offset the inevitable attrition, which normally runs 10 to 15% of the membership. Last year, 39 members failed to pay their 2013 dues and forfeited their membership, while 15 more went to "Final Muster". Until we can find and elect a First Vice, I may appoint a "membership officer" as an interim measure to keep recruiting and retention alive. And, remember, "Membership is everyone's concern!"

Meeting Attraction: You might see the connection between this problem and the fact we have vacancies. Last year we drew only 20 members to each meeting, on the average. Despite my plea to include two or three new faces to the officer corps, that "suggestion" was ignored or it was tried and failed. Any Nominating Committee and the electorate needs to know enough about the members nominated to have confidence in some their capability. That "requirement" rules out a huge percentage of the membership. Further, we need to check out incoming transfers for Legion experience. Meeting attendance is one of the qualifications to serve as an officer! Think of meeting participation as an Officer Candidate School.

Public Relations: Think of PR as two separate efforts: (1) The constant alertness for Post events and news which might be "newsworthy"; a PR opportunity, to be written up, photographed and submitted to the media via Donna Wick; and (2) the several actions which have "in-house" impact and help to unify the membership, as defined as "early-action" in the PR Plan. Call those "non-public relations". I have appointed David Glover as "Public Relations Coordinator" to handle the first aspect of PR and to interface with Wicked Publicity. So alert David to any newsworthy event and feed him write-ups you may develop. It's always important to get our name out in the community and help our veterans and their families.

On a related matter, I will be asking Jim and Emery about mailing out the Bugle, say, quarterly. About 40 per cent of the membership have given us no e-mail address and may not be reaching the Website. That's almost 130 members who hear nothing from the Post, but are getting monthly reminders from National to "Pay Your Dues!" We can afford to budget the mailing cost and any new preparation cost, if volunteers to work with the Editor do not come forth.

There are many people in our organization who help make it successful. Without all of you, we could not have rummage sales, send high school juniors to Boys State, participate in parades and give scholarships. Thanks to **Emery** for bringing drinks to meetings and to Harlen for taking care of our unserviceable flags. Thanks to those who volunteer to help interview the Boys State and scholarship applicants. I have also committed to more social activities either at our meetings or other venues. There are so many people who have helped over the past year! If I have not named someone for their work or volunteering, please know that your work and help are very much appreciated.

My thanks to the Auxiliary and its new officers, who have shown deep interest in working closely as a team. Without the Unit, it would be very difficult to get as much done as we do. We also appreciate the meals they provide, largely out of their own purses, to top off our monthly meetings.

Kim Biggerstaff represented the Post at the Department Convention in McAllen. The members elected as Department Commander Lynn Sparks. Congratulations to Lynn for her selection and new responsibility. Let us all give her our total backing.

The District 7 Fall Convention is scheduled for October 18<sup>th</sup> at Post 95 in Huntsville. The venue is the meeting hall adjacent to the Veterans Museum of Texas. Saturday starts with a light breakfast and registration beginning at 7:30 AM. The Joint Session commences at 9:00 AM. We will be selecting Delegates, recognizing that the Convention conflicts with our Fall Rummage Sale. The next meeting of the Post and Unit takes place on August 21<sup>st</sup> at the Community Center at 7:00 PM.

The Bugle is saddened to report on the loss of another member – Warren E. Natusch. He was called to Final Muster on July 15<sup>th</sup> at 91 years of age. Warren, a former World War II Marine (assigned to pacific-based Marine Air units) had only been with Post 305 for 18 months, having moved here from Greensboro, NC, and transferring from his Greensboro Post. He had been a Legionnaire for 10 years. Warren depended on a walker to get around and was helped to our meetings by

his son-in-law, in whose home he lived. In that respect, he was a better Legionnaire than the majority of able-bodied members. Warren was a member of the YMCA and hardly missed a day of workout – on a fitness machine, in a Silver Sneakers gym and even walking the track oval – in his 90's yet! ### DEFENSE FINANCE AND ACCOUNTING SERVICES IS CHANGING ITS MYPAY ACCESS SYSTEM

Each year, the myPay system of DFAS is upgraded to meet technical and security requirements, as well as to add new and improved functions for its 6.6 million account holders. The Spring 2014 release, implemented on May 17th, delivered password rules more in line with the online banking industry standards, while maintaining DFAS' commitment to system personal securitv. and Α number of functional additions and enhancements for military retirees, service members and federal civilian employees have been designed to increase its customers' ability to easily manage their pay.

What changed for retirees on May 17th? Simplified passwords: myPay password rules now allow for simpler, more memorable passwords while ensuring passwords remain strong and more secure. While still meeting the intent of DoD cyber security rules, passwords can be shorter and will last longer between changes. Current users who access their account using a log-in password will be able to create a new password of 9 to 30 characters in length. Additionally, the newly reset password will valid for 150 be days.

"Balancing security with usability can be challenging with the state of cyber security today," said Dave McDermott, DFAS deputy director for "This Operations. update addresses customers our concerns for creating simpler, more memorable passwords while ensuring passwords remain strong and more secure." Starting May 17th, passwords must:

- Be 9 to 30 characters in length.
- Contain at least one
   UPPERCASE letter.
- Contain at least one lowercase letter.
- Contain at least one number (0-9).
- Contain at least one of the following special characters: # @ \$ ^ ! \* + \_ %.

Passwords will remain valid for 150 days. About 10 days before expiration, users will be notified via SMARTDOCS by email to change their password. The password reset security questions introduced in 2012 will be very important to allow users to reset passwords online and avoid calling the DFAS Care Center for assistance. ### MILITARY COMPENSATION AND RETIREMENT MODERN-IZATION COMMISSION INTERIM REPORT

On July 3rd, the Military Compensation and Retirement Modernization Commission (MCRMC) issued a 358-page interim report ahead of the release of its final findings. which are expected in February 2015. The MCRMC was established by Congress in 2013 to study all aspects of military compensation and to suggest reforms that will ensure the long-term viability of the allvolunteer force, foster recruitment, sustain retention and modernize military compeninterim report sation. The makes no formal recommenddations and instead focuses on providing background information on the current military compensation system.

The report attributes military personnel cost growth in the past 20 years to inflation (particularly medical inflation), policy changes counteracting recruiting and retention challenges. plus personnel funding to support 13 years of war. In addition, the establishment of several new benefits for servicemembers and veterans (e.g. the Post-9/11 GI bill) has contributed to the growth. More importantly, the MCRMC found that regardless of the reasons behind this growth, military compensation funding has consistently comprised roughly 30 percent of the DoD budget; however, the report also stipulated that this does not necessarily provide evidence of fiscal sustainability. The interim report makes it clear that the Commissioners believe that a broader discussion of federal spending levels is necessary to ensure the viability of the allvolunteer force. The Commission is undertaking a comprehensive review of existing programs compensation to provide a full and nuanced understanding of what it takes

to sustain needed force levels during all levels of conflict and economic conditions. This includes pay, retirement, health benefits and quality of life programs.

The interim report does not reveal the leanings of the MCRMC. It's still unclear if the Commission will propose drastic compensation reforms in its final report. #### HOW THE GREAT WAR EVOLVED

One hundred years ago, the war which spawned **The Amer**ican Legion was begun by a teenage thug whose crime unleashed a series of pent-up desires and ambitions. One thing after another went wrong on the morning of July 28, 1914, in Sarajevo, capital of the

Austrian province of Bosnia. The motorcade carrying Archduke Franz Ferdinand, heir apparent to the Austro-Hungarian throne, through the city got lost. The driver of the open touring car in which the archduke and his wife, Duchess Sofie, were riding made a wrong turn into a narrow street. The car had no reverse gear and had to be pushed back to the main thoroughfare. By purest chance, it had come to a complete stop exactly in front of a 19-year-old Bosnian Serb nationalist, Gavrilo Princip, who had been assigned to assassinate Franz Ferdinand. Princip was an inexperienced marksman, armed with an underpowered .32 caliber handgun. Nevertheless. he managed, with two shots, to kill the archduke and duchess.

The assassin had been recruited and equipped by anti-Austrian factions in Serbia. The Serbian government was not party to the act but was almost certainly aware of the plot. Serbia wanted to break Bosnia away from the Austro-Hungarian Empire and make it part of a greater Slavic nation in the Balkans. More than 40 percent of Bosnians were ethnic Serbs.

There was widespread rejoicing and celebration in Serbia at the success of the assassination. Official condolences did little to moderate the public jubilation, and neither did commentary in the Serbian nationalist press. The Serbian government was not as innocent as it claimed.

Sarajevo was the spark that led to World War I. On the day of the assassination, Europe was at peace. Less than six weeks later, it was at war! Austro-Hungary, with the full backing of Germany, declared war on Serbia, causing Serbia's ally, Russia, to mobilize. Germany issued an insulting ultimatum to Russia and its ally, France, to stand down and stay out of it. In August, Germany invaded Belgium en route to attack France. This act drew in Great Britain. And the rest is history.

But, think of what events are going on now in the same region of Europe. Could we be watching the start of World War III?

#### REBECCA YOUNG, MARY PICKERSGILL AND CAROLINE PURDY

Who are these ladies and why are they remembered here? Well, they are related, and they played an important part in the history of America 200 years ago. The bond which ties them in that regard is the United States' flag known as the Star Spangled Banner, the flag which inspired Lt. Francis Scott Key, who once led a contingent of riflemen under Lafayette at the Battle of Yorktown.

In 1807, these three women moved into a house on Albermarle Street in Baltimore. Marv Pickersgill was a widow at 30 years of age, and Rebecca Young was her grandmother, also a widow. Caroline was Mary's daughter. It was Rebecca Young who made the first unofficial flag of the revolution under General George Washington's directions, called the "Grand Union". Mary Young was born in the year of independence - 1776. Thirty years later, widow Mary Young Pickersgill was called on to follow in her grandmother's footsteps: she was commissioned by Commodore Joshua Barney and General George S. Stricker, who had family connections, to make a flag for nearby Fort McHenry.

In August 1814, the United States had been at war with the British for two years. Now, the Redcoats had invaded and Washington was afire. The British turned to Baltimore where defenders under General Samuel Smith had erected lines of defense, manned mostly by militiamen from Maryland, Pennsylvania and Virginia. Fort McHenry, completed around 1800, was there to protect the entrance to Baltimore Harbor, and was garrisoned by one thousand men. It was key to the defense of Baltimore.

Major George Armistead, Commandant of Fort McHenry, commented a year earlier to General Smith, "We are ready at the Fort to defend Baltimore against the invaders, except that we have no suitable ensign to display over the star fort, and it is my desire to hoist a flag so large that the British will have no difficulty seeing it from a distance." That desire led to the request that Mary Pickersgill create a large flag for the Fort. The garrison flag she made was 30 feet high by 42 feet wide, with 15 five-pointed stars, each two feet across, arranged in five indented, parallel lines, three stars per line. It had 15 stripes, each two feet wide. This design had been left to the skill of the flagmaker.

Mary's daughter, Caroline. helped her mother make the flag. In 1876, in a letter to her girlhood friend, Georgiana Arm-Istead Appleton (daughter of the Fort Commandant), Caroline Pickersaill Purdy recounted details of making the flag. The flag was so large that Mary got permission of the owner of Claggett's Brewery to spread the flag out on the malthouse floor where she placed and sewed the stars.

In 1938, the original receipt for the flag came to light. The receipt shows that Marv Pickersgill was paid \$405.90 for the flag by "G. Armistead. Major", specifying "Fortification Voucher No. 10. Mary Pickersgill for flags." (The second flag listed was a smaller storm flag used in high winds.) The flag was delivered to the Fort on August 19, 1813. The British bombardment took place a year later on September 13 and 14, 1814, as lawyer Francis S. Key and Colonel John S. Skinner, who were under a flag of truce but retained on a British ship, watched as the Fort was shelled by 19 British ships.

Today, the Fort McHenry flag, the Star Spangled Banner, hangs in glory in the Smithsonian's Museum of History and Technology.



**Footnote:** Francis Scott Key penned the start of the words which later became "The Star Spangled Banner" on the back of an envelope that night. They were set to a well-known English tune and printed as a handbill soon following the battle and became very popular throughout the land. But, it became our official National Anthem by Public Law 823 of the 71<sup>st</sup> Congress and signed into law on March 3, 1931 by President Herbert Hoover.
