#### MEETING HIGHLIGHTS (November 20, 2014)

In the absence of **Commander** Koch, who was still on holiday across the "pond", presiding Acting Commander was Everett Ison (usually Judge Advocate), who opened the meeting in the usual manner. The first order of business was the clearing of two sets of minutes. Since the last meeting was the picnic, with a short agenda, those minutes as well the minutes of the as September meeting had been tabled and not approved. Those were minutes read and approved. excepting the following. The only past motion which was set aside was a motion to consolidate the General Fund and the Money Market Fund, so this action proceeded. With the minor interest it earned and the need for a little more cushion in the General Fund, the motion to consolidate the two funds passed. There was little benefit in maintaining the separate Money Market Fund, so it will be rolled into the General Fund.

Next, the Acting Commander asked if there were any new members and Dennis La Plante was welcomed. He was voted upon and approved. The Acting Commander, in his remarks about membership, noted that there are over 8,000 veterans in The Woodlands and its environs, many or most of whom are eligible for membership in the American Legion.

The financial report was given by **Finance Officer Jim Bolin**,

to wit: the General Fund held \$2,211.50; the Money Market Fund \$6,215.41; and the Investment Fund \$30,077.23; for a Total Assets of \$38,504.14.

Calling for Chaplain Glover's Commander report. the thanked her for her services at Town Green the Park groundbreaking. where she rendered to the unplanned Chaplain service. Glover reported next and updated us on the health status of Joe Watz and Dutch Dettinger, who both are under hospice care at comfortable locations. She also reported that Gene Wilson is scheduled for back surgery and could use our good wishes.

Historian Win Salter reported he had received the Post's History Book back from the National Contest and learned it placed second in its category. A modest round of applause followed. Service Officer Dayton Denton, in his report to the membership, said that he and Steve McKinsey will be care taking personal and morale items, ball caps, and lap robes to the VA hospital on Friday.

Under New Business, the Post considered two resolutions of endorsement: One for the candidacy of **John Hinds** for Department Vice Commander, and another for our own **Kimberly Biggerstaff** for 7<sup>th</sup> District Commander. The Post supported both as viable candidates for the elections in June.

There being no other business to come before the membership, the **Acting Commander** closed the meeting in the prescribed manner, then turned the meeting over to **Dayton**  **Denton** to honor our most recent group of Boys' State attendees. We sent 18 boys this year, and **Dayton's** goal for next year is a "bus full".

A special Thanksgiving pot-luck supper, prepared by the Auxiliary, was enjoyed by members and guests alike.

#### UNDER OLD "OLD BUSINESS"

The Bugle files and past issues often reveal old Post business which has become forgotten business or unresolved issues, some time-critical; others just out there. Here are three examples:

~ At our June meeting (of last year - 2013-2014), The Commander, in an effort to better unite us, offered to help pay for a regulation cap for each new member going forward: \$10 from his pocket; the balance as a loan from treasury, to be repaid over an extended period. Although reminders of this incentive have appeared in the Bugle, none was included since our Open House, where several new members have joined. If you are capless or wear otherthan a Post 305 cap, and have joined this Post since the June 2014 meeting, see Adjutant Jones for help in ordering a cap or for reimbursement.

~ It is not too early for you amateur cooks and saddle tramps to consider whether or not you will compete in the Post/Unit Annual Chili CookOff at the January meeting. It will be Unit versus Post again.

~ Last February, the VA began issuing its new Veteran Health Identification Card to newly enrolled veterans and those not previously issued the old ID card. **Service Officer Dayton Denton** has offered to assist Post members to obtain the new card, which is available at the Conroe VA Clinic. It also can be applied for online or by phone:<www.va.gov/healthben efits/enroll> or 1-877-222-8387. You will need two forms of identity to apply and your picture will be taken.





#### 2015 CHANGES IN VA'S ELIGIBILITY RULES FOR HEALTH BENEFITS

VA's То align healthcare program with the financial assessment requirements for other federal healthcare programs, the VA has approved a process change to cease collection of veterans' net worth information for purposes of testing for health means benefits. Effective January 1, 2015, VA will only consider a veterans' previous year's gross household income (earned and unearned income) and deductible expenses to determine eligibility and/or copay responsibility for purposes of VA enrollment/benefit healthcare entitlement. Note that this does not impact net-worth estimates VHA's for purposes of

Extended Care Services or VBA's Pension Program. Software changes to remove the net worth prompts from VistA and the Enrollment System are expected to be released in the second quarter of FY 15. Until the software is implemented, VA intake staff will enter "zero-dollars" (\$0) into the net worth prompts for new applicants' or when updating an existing enrollees' Means Test. Changes to the online application and VA Forms 10-10EZ /EZR and 10-10HS are expected to be available by January 1, 2015. #### VA REVISES ACCESS TO OBAMACARE (ACA)

The Department of Veterans Affairs updated its website with a new page containing information on the Affordable Care Act (ACA). The page is easy to navigate, and is broken down into different links for veterans already enrolled in VA care, unenrolled veterans, and family members. Those who are not enrolled yet can use the site to learn more about eligibility, begin the enrollment process, or initiate an online chat for more help. There are also various fact sheets and FAQs available. As a reminder, all enrolled veterans, TRICARE beneficiaries, and CHAMPVA family members already meet the minimum standard for coverage required by the ACA. ### HOMELAND SECURITY AND MILITARY NEWS

#### ARMY AND MARINES MAY BENEFIT FROM NEW CONCEPT IN FIGHTING VEHICLE

Since WWI there has been a constant arms race between the development of anti-armor weapons and ground-vehicle protection systems. As anti-tank weapons continued to get more effective, old solutions of simply increasing the level of armor may make future armored vehicles too large, heavy and expensive to be useful. This challenge was taken up by DARPA (Defense Advanced Research Projects Agency) the challenge being to identify ways to break the "more armor" paradigm that has been the answer to vehicle protection for the past century. The goal is to next-generation make the armored vehicle smaller, faster and more maneuverable than current vehicles. DARPA is adopting the Air Force concept of "X-plane" development which has improved aircraft capabilities by engaging in groundbreaking fundamental R&D. In August 2014, DARPA started a new program with the technical goals of:

~Reducing vehicle size and weight by 50 %.

~Reducing crewmember needs by 50 %.

~Increasing vehicle speed by 100 %.

~Accessing 95 % of terrain, and ~Reducing detectable signature (visible, infrared, acoustic and electromagnetic)

In May, DARPA announced its "Ground X-Vehicle Technology" (GXV-T) program, and the Army Tank Automotive Research, Development and



Engineering Center (TARDEC) made public 24 pages of concept drawings of possible GXV designs. Some of the vehicle features and capabilities included (a) a swiveling turret which could "sense" an enemy sniper and destroy the threat, (b) capability of an air-drop eight GXV's in one C-17 – and transporting up to 96 soldiers over rough terrain and urban environments. (c) four independent tracks that can maneuver like wheels, and (d) "movable armor" which can deflect incoming rounds and stopping rocket-propelled grenades in mid-air using an undefined weapons system.

On September 5, 2014, DARPA held a "proposers' day" event to clarify to potential contractors and other stakeholders the project's requirements. Initial development contract awards are planned for April next year or sooner. [Reference: Army Times; September 10, 2014]

#### PEARL HARBOR

**December.** This is the month when we wish one another a merry Christmas and a happy new year; or perhaps other faith-based greetings. Since 1941, we added to those expressions "Remember Pearl

Harbor", just as earlier generations remembered the Alamo and the USS Maine. No one alive in 1941 will ever forget the "day which will live in infamy", unless they were too young, and later learned of the attack as history. The US Pacific Fleet seemed virtually crippled, and we lost over 2,400 servicemen killed and another 1.100 wounded. In the aftermath of the attack. the US declared war on the Empire of Japan and went to work to crush that menace. The ensuing mobilization of the US was total industry, the military, the administration and the home-front. Pearl Harbor overnight silenced the considerable number of "America Firsters" and other isolationists. And, we had the will and leadership to not just "turn the other cheek". A similar reaction was seen following September 11, 2001, as "Remember 9-11" was added to our inspirational mottos.

In today's world, it could happen again. Not a surprise attack on an Oahu naval base, but some enemy or terrorist action just as hurtful and damaging. Let us pray we have the leaders and sense at all levels to respond as well as our 1940's team did.

Each year, Post 305 sponsors the sending of local high-school juniors to the Department's Boys' State Convocation. This year (2014) the Post sponsored 18 boys to attend the week-long session in Austin. Eleven of the 18 boys appeared on November 20<sup>th</sup> to be recognized and honored.

The Post owes the success of this program to its Service Officer, **Dayton Denton**, and to the highschool counselors who nominated the boys for consideration and interview by the Post Selection Committee.
