We have a busy time of year as we enter the month of October.

During the meeting we will honor our members. deceased The Traveling Trophy, which we have won for baseball caps and other donations, will be canned goods, non-perishables and/or baby supplies. On October 31st, the Montgomery County Constable is having a BBQ for all the veterans of Montgomery County. The BBQ will be in the large room of the South County Community Center (SCCC). He has asked for our help, and we have told him that we will have some people there to help. From what I understand, that means to help people to find a place to sit. So if you are interested, you are welcome. Bring some membership applications just in case one of the attendees would like to be a member of the Post.

Every year the Post celebrates the returning Boy's State attendees with some remembrances' and a Thanksgiving sized supper. However, the Post must conduct some business, limiting the time for recognizing the Boy's State attendees. Dayton Denton, the Boy's State program manager, wants to try something different, given the large number of boys and girls sponsored by the Post and Auxiliary. At Dayton's suggestion, a special meeting is scheduled for Tuesday, November 3<sup>rd</sup> to which all sponsored Boys State and Girls State grads and their parents are invited, to be introduced and honored. The gathering will commence at 7:00 PM in the same large room of the SCCC

as we usually meet. There will be a short opening ceremony to make it under the auspices of the Post. From then on **Dayton** will take over as master of ceremonies. Now, I have spent a lot of space detailing what is just ahead of us because I need your help by attending the fun things, as well as the not so fun things, called Post business. I want to congratulate **Finance Officer Emery Heuermann**, for the impressive achievement of revamping the way we do financial business. As an offshoot of this, he was able to offer a completely revised budget for the 2015-2016 year. It was voted in with the amendment that the budget be reviewed after three months.

Post dues will soon be increased as a result of National requiring an additional \$5.00 per year per member. The Department is passing that increase to its Posts, which means its portion of your dues will increase from \$26.00 to \$31.00. Each Post must decide what change in its annual dues will apply; a matter for the Executive Committee. Further, the Department has given its Posts the choice of one of three dates when any change will take effect: (1) As of the November Renewal Notice; (2) As of the January Renewal Notice; or (3) As of a date set by the Post, no later than

January 13, 2016. Stay tuned for those decisions, which must be made by our November Meeting. Membership That should encourage you to remit vour current dues ASAP or accept a higher rate. Further, now is a good time to consider changing to Paid Up For Life (PUFL). Not only are the yearly dues increasing, but the PUFL cost will also be increasing. By buying now, you will beat the large increase to the PUFL cost, and you will not have to worry the next time an increase in dues is promulgated. Neither will you be bothered by dues reminders and writing annual checks.

## HONOR FLIGHT SELECTEES FOCUS ON WOMEN VETERANS

VA Secretary R. A. McDonald spoke to more than 140 WWII veterans who are part of the first all-female Honor Flight. These woman vets visited Washington's memorials built to honor their service. One Flight arrived in D. C. on September 22, comprised of 70 female WWII veterans, plus 70 post-9/11 era female veterans. The Secretary of Veterans Affairs attended a short ceremony and offered his thanks at the Women in Military Service Memorial at Arlington National Ceremony.

## <u>MY HEALTHeVET, FYI</u>

"My HealtheVet" is the VA's online personal health record, designed for veterans, activeduty service members, their dependents and caregivers. It helps veterans partner with their health-care team, and provides opportunities and tools so that vets can make informed decisions in the management of their health care. Specific features available to veterans are based on his or her account type. Users of MyHealtheVet who have a Basic account are able to view their self-entered information online. If a vet is a

VA patient, he or she can upgrade their account to <u>Advanced</u> or <u>Premium.</u> For more information about account types and what is viewable, visit:

## MyHealtheVetAccountTypes

Among the newest features available to veterans with a Premium account is the inclusion of "VA Notes". Those are clinical notes that your health-care team records, made during your appointments or hospital stays. Also available are your immunization records, more detailed reports, and a list of your current medical issues. These features are additional to prescription refills, VA appointments, and secure messaging all quite popular to veterans. [Source: Dept. of Veterans Washington. Affairs. The damaging effect of exposure to high noise levels in military operations or during routine military training is insidious, and many veterans do not realize they have hearing loss until permanent damage has already occurred. VA audiologist Nancy Duran, of VA's Audiology and Speech Language Pathology Services, recognizes the importance of caring for veterans who experience difficulties with their hearing, balance, speech, and communication ability. Hearing loss and tinnitus (ringing in the ears) account for the two most prevalent. service-connected disabilities among veterans. VA audiologists provide comprehensive hearing health care services, including:

~ Disability audiology exams and medical opinions on the

relationship between military service and hearing loss, tinnitus and balance disorders. ~ Assessment, evaluation,

treatment and management of hearing loss, tinnitus and balance disorders.

~ Fitting and programming hearing aids and other assistive listening devices, such as TV and telephone amplifiers and post-surgical rehab for cochlear and other auditory implants.

~ Hearing screening, noiseinduced hearing loss preventive services and aural rehab services to optimize hearing.

The VA includes over 1,100 audiologists at 400 sites and more than 400 speech-language pathologists offering services at over 190 sites of care.

## THE MIRACLE OF ST. NAZAIRE (A WAR STORY)

This miracle is not a churchbased tale of religious significance, enhanced by retelling over the ages. This miracle is well documented and involved Staff Sergeant Alan Eugene Magee, an Eighth Air Force ball-turret gunner of the 303<sup>rd</sup> Bomb Group, one of ten crew members of a B-17G Flying Fortress ("Snap!Crackle!Pop!").

On January 3, 1943, Magee's bomber was one of 85 planes which carried out a daylight raid on the German submarine pens at St. Nazaire, France, It was Magee's seventh mission. He was old – 24 years – and was able to squeeze his 5'-7" frame and his 155 pounds into the belly turret of the B-17. (The pilot, Captain Arthur Adams, was only 19) On the day of the raid, Magee left his parachute on the aft deck of the bomber, because of the cramped space of his "office".

The formations of bombers formed up above their English bases and followed the lead plane to France. They soon encountered heavy flak and defending German fighters as they approached the port city. Snap!Crackle!Pop! was hit by anti-aircraft fire on a wing and one engine, then a German fighter shot off a section of the right wing. The doomed bomber started spiraling toward the ground, spinning at a high rate. The crew tried to abandon the crippled plane but only three crewmen got out. Two parachuted into the sea offshore navigator Lieutenant Glen M. Herrington and tail gunner Staff Sergeant J. I. Gordon. Magee wounded, climbed from his turret and found his parachute ruined. He bailed out without a 'chute and lost consciousness due to the altitude, falling over 20,000 feet to earth. He likely had reached terminal velocity (120 mph) when he crashed through the glass roof of the St. Nazaire railroad station and

became draped over а supporting steel girder, then dropped to the floor. Magee was critically injured but was alive! He was given medical attention, suffering 28 shrapnel wounds, a damaged lung and kidney; his right arm was almost severed; his nose and one eve were ripped open and his broken bones included his right leg and ankle. With German doctors' care, Magee fully recovered. He was a POW until May 1945. He was awarded the Air Medal and the Purple Heart.

That raid on St. Nazaire was considered a failure by the Eighth Air Force. Seven bombers were destroyed and 47 were damaged that day. In all, 75 airmen died.

Magee, despite his wartime experience, earned his private pilot's license and found a career in air freight and airline reservations. In September 1995, the townspeople of St. Nazaire hosted a banquet where Magee and the two other survivors of Snap!Crackle!Pop! were guests and a monument to the bomber's seven crewmen was dedicated.

Magee retired to New Mexico in 1979 and died in 2003 at age 84 of complications of a stroke and kidney failure. His grave is in San Angelo, Texas.

#### **REMEMBER OUR VETERANS**

You're a 19 year old kid, You are critically wounded and dying in the jungle somewhere in the Central Highlands of Vietnam. It's November 11, 1967 at Landing Zone Xray, Your unit is outnumbered 8 to 1, and the enemy fire is so intense from 100 yards away that your CO has ordered the Medevac helicopters to stop coming in. You're lying there listening to the enemy machine guns and you know you're not getting out. Your family is half way around the world, 12,000 miles away, and you will never see them again. As the world starts to fade in and out, you know this is the day, Then, over the machine-gun noise, you faintly hear the sound of a helicopter. You look up to see a Huey coming in, but it doesn't seem real because there are no Medevac markings on it. Captain Ed Freeman is coming in for you. He's not Medevac, so it's not his job, but he heard the radio call and decided he's flying his Huev down into the machinegun fire anyway. Even after the Medevacs were ordered not to come. He's coming anyway. And, he drops it in and sits there in machine-gun fire as they load three of you at a time on board. Then he flies you up and out through the gunfire to doctors and nurses and safety. And, he kept coming back - 13 more times! Until all the wounded were out. No one knew until the mission was over that the Captain had been hit four times in the legs and left arm! He took 29 of you and your buddies out that day, Some would not have made it without the Captain and his Huey.

Medal of Honor recipient Captain Ed Freeman, United States Air Force, died last Wednesday at the age of 70 in Boise, Idaho. May God bless and rest his soul!
