### VETERANS' CONSENSUS: ESTABLISH PRIVATE CARE OR OVERHAUL VA

Members of both parties in repeatedly Congress have promised in recent months not to fully privatize VA health services, but have advocated for more partnerships with local hospitals and research centers to expand access to veterans. Veteran association officials said they see the clear message from various recent surveys as "the preferred method to achieve (the best care for veterans) is to hire more VA doctors. hold wrongdoers accountable, improve customer service, and make VA's programs and systems more user-friendly." #### RESERVATIONS AVAILABLE AT NATIONAL CEMENTERIES

Since first announced last December, more than 10,000 eligible veterans have taken advantage of a new VA benefit that allows them to pre-enroll for interment in a VA National Cemetery, which means less paperwork that survivors will have to complete following their loved one's death. Interested veterans can submit VA Form 40-10007, Application for Pre-Need Determination of Eligibility for Burial in a VA National Cemeterv. available at: https://www.va.gov/vaforms/va/ pdf/VA40-10007.pdf, and supporting documentation, such as a DD Form 214, if readily available, to the VA National Cemetery Scheduling Office by toll-free fax at 1-855-840-8299; by email to Eliaibility or .PreNeed@va.gov; or by regular mail to the National Cemetery Scheduling Office, PO Box 510543, St. Louis, MO 63151.



VA will review applications and provide written notice of its determination of eligibility. VA will save determinations and supporting documentation in an electronic information system to expedite burial arrangements at the time of need. Because laws and personal circumstances change, upon receipt of a burial request, VA will validate all predeterminations need in accordance with the laws in effect at that time. VA operates 135 national cemeteries and 33 soldiers' lots in 40 states and Puerto Rico. More than 4 million Americans, including Veterans of every war and conflict, are buried in VA's national cemeteries. VA also provides funding to establish, expand and maintain 105 veterans cemeteries in 47 states and territories including tribal trust lands. Saipan. Guam, and For Veterans buried in private or other cemeteries. VA provides headstones. markers or medallions to commemorate their service. In 2016, VA honored more than 345,000

Veterans and their loved ones with memorial benefits in national, state, tribal and private cemeteries.

Eligible individuals are entitled to burial in any open VA national cemetery, opening/ closing of the grave, a grave liner, perpetual care of the gravesite, and a government-furnished headstone or marker or niche cover, all at no cost to the family. Veterans are also eligible for a burial flag and may be eligible for a Presidential Memorial Certificate. ### NATIONAL MALL SITE RESERVED FOR MEMORIAL TO DESERT SHIELD/STORM VETERANS

Veterans of Operations Desert Shield and Desert Storm will soon have their own memorial National on the Mall in Washington, D.C., thanks to legislation signed March 31st by the president. President Trump signed Senate Joint Resolution 1, "A joint resolution approving the location of a memorial to commemorate and honor the members of the Armed Forces who served on active duty in support of Operation Desert Storm or Operation Desert Shield." The resolution was sponsored by Indiana Sen. Joe Donnelly and Arkansas Sen. John Boozman and designates the location of the memorial on the National Mall.

### **CRUISE MISSILES**

Obama is said to have drawn "a red line in the sand" with respect to use of chemical weapons in the Syrian civil war. In actuality, House Speaker John Boehmer a year later gave the challenge that specific term, referring to Assad employing poison gas against his citizens. By that time, it was said that the US was prepared to use "cruise missiles" against Syrian targets, but no such action was taken.

On April 7, 2017, the US launched 59 cruise missiles on Shayrat Airfield in Syria, the base from which one or more fighters flew mission(s) to bomb Syrian civilians with chemical gas including sarin gas. The US attack was from two guidedmissile destroyers in the Mediterranean – the USS Porter (DDG-78) and the USS Ross (DDG-71).

The US has used cruise missiles as early as 1991 in the Gulf War and previously in 2011 when they were fired against 20 targets in Libya. The missiles were "Tomahawks" and are deployed in two versions: "Block III Tomahawks" are programmed in advance to strike a specific target, then launched. The later "Block IV Tomahawks" have greater capabilities, including the ability to change course or targets after launching. These can also "hover" or circle for extended periods of time before actually striking.

Cruise missiles are "flying bombs" which were first used by Germany in WWII as the primitive V-1 rocket. Bv definition, they are unmanned, self-propelled, guided missiles that sustain flight through aerodynamic lift over most of the flight path and whose primary mission is to place an ordnance payload on a target. They are inexpensive to build and can, therefore, overwhelm opposing defenses by sheer numbers. They can be designed to be small with low-thrust engines and can penetrate radar and infrared detection networks. They require no flight crew expensive training, no or complex upkeep, no hangars or large airbases. With these characteristics, it is especially difficult to collect intelligence on development and to their anticipate an evolving threat. At least 12 countries have developed. possessed and exported cruise missiles. In general, cruise missiles are small and have limited range. Instead of the usual high explosive payload, it is possible to convert cruise missiles to deliver WMD's, but their short range and other aerodynamic characteristics restrict such higher lethality. At least 30 thirdworld countries have purchased or were given cruise missiles of various types. The suppliers/ include the United sellers States, Great Britain, China, France, Germany, Israel, Italy, Japan, Norway, Russia. Sweden and Taiwan. In 1982, Argentina fired French "Exocet" missiles at the Royal Navy's

ships during the Falklands War, sinking the *HMS Sheffield* and a transport ship.

### WORLD WAR II IN EUROPE ENDS

On May 8, 1945, 72 years ago, the unconditional surrender of the remaining Axis Powers was effected. The act of military surrender was signed by the Allies on May 7<sup>th</sup> in Reims, France, and then by Germany on May 8<sup>th</sup> in Berlin. The Soviet Union, which wanted all parties appear in Berlin (which it to held) for one grand event, was absent at Reims. and recognizes the war's end as being May 9<sup>th</sup>, together with the Eastern Bloc countries.



Adolph Hitler was dead by his own hand (on April 30, 1945), so the German surrender was represented by Admiral Karl Donitz. The Italians had surrendered on September 8, 1943, as Mussolini lived on in exile under Nazi protection. He was captured and killed by Italian Communist resistance fighters on April 28, 1945.

Although V-E Day was a cause for celebration, Japan had yet to fall and would not accept the fact the war was lost as US troops captured its more distant island lands.
