MEETING HIGHLIGHTS (September 21, 2017)

Commander Victoria Glover called the meeting to order and conducted the prescribed ritual, aided by **Chaplain Bill Houghton** and **Sergeant-at-Arms Bruce Carter**. The first order of business was the review and approval of the minutes of near past meetings; to wit: Post Membership meeting of August 17th; Finance Committee meeting of September 15th; and Executive Committee meeting of September 18th. Each was voted to be accepted in turn.

Commander Glover asked if there were any guests present, and the **Sergeant-at-Arms**

cited **George Viravec**. He introduced himself and stated he had served in the USAF with two tours of duty in Vietnam as the equivalent of an MP. He is a candidate for Post membership.

Finance Officer Emery Heuermann was called on to give his report. The General Fund, at the close of July, was at \$8,832.78; and the Investment Fund totalled \$33,102.25; for a Total Assets (Liquid) of \$41,935.03. **Emery** stated he also had the 2017-2018 budget to present later.

First Vice Commander Jim Bolin was next. He reported that paid membership numbered 86 toward a goal of 322, but that omitted any on-line payments which had yet to be reported by the Department. Notice of dues payments made on-line are not readily conveyed to Posts, unlike dues paid by check directly to **Adjutant Pickens Jones**.

The **Adjutant** and the **Chaplain** had no report. **Judge Advocate Everett Ison** reported next, and he distributed the four-page summary Audit Report (Financial) covering the year ending June 30th. He then presented it, citing its high points. Among the recommendations were the need to re-establish files on each member to include proof of qualifications to belong to the American Legion and such other personal data and information which would permit the officers

to better know the members. (Legion history, past officerships held, family situation, special skills and qualifications, etc).

The **Judge Advocate** went on about the Standing Rules which were recently adopted pending clarification of one matter: the timing of completion of the annual audit. He explained how that phrase was revised.

Historian Win Salter had nothing to report. **Service Officer Toby Carroll** told of encountering three veterans who were assisting homeowners who had flooded homes. One, who had been certified at 100% disability by the VA, was reduced recently to 70%, with reduction in pension. **Toby** will be attending the Service Officer training session in Austin and will confer with others on the prevalence of such VA action.

Next, the **Finance Officer** was called on to present the budget for the current year. Copies of the proposed budget were distributed, and it had been reviewed and approved by the Executive Committee. **Emery** pointed out several line items which deserved attention and the bottom line, where an imbalance was shown between income projections and estimated expenses. The budget includes interest drawdown from the Investment Fund above \$31,000, which lessened the imbalance. By motion and vote the budget as presented was adopted.

Continuing, **Emery** reported on action endorsed by the Executive Committee to sell the current fund (FASIX) and buy a more productive Fidelity fund for the original \$30,000 and to add any earnings to the General Fund, thus allowing greater aid to veterans and offsetting the

2016 and 2017 shortfall and absent Rummage Sale income.

He has met with the broker and has selected the replacement fund, which holds 70% equities and 30% bonds. By motion and vote the described action was adopted.

First Vice Commander Bolin spoke of the tradition of the Post buying \$40 worth of chances for a drawing at the 7th District Convention in Crockett, indicating he would continue the practice. **Jim** also indicated that the Top Golf driving range was still trying to interest the Post in participating in a fundraiser, however the scale of their typical contest is way above anything the Post could handle. He surmised it might be more appropriate at the District level.

Commander Glover recognized that the Rockport Post facilities were badly damaged by Hurricane Harvey. She also reported that she is receiving many offers of help from far and wide. But, the officers have virtually no knowledge of how the 300+ members fared. The Post is aware that three officers had their homes and property severely damaged by flood water – **Dayton Denton, Art Eipper** and **Win Salter**.

Emery Heuermann rose to state that with so many Post members giving aid and comfort to the flood victims, those helpers should report on their good deeds for reflection in the annual Consolidated Post Report.

Judge Advocate Everett Ison (and the Panther Creek scion) rose to say that he personally was reserving two, trailer-spaces for the Post and the Auxiliary to have booths at The Woodlands Annual Flea Market

CHANGES TO TRICARE FOR 2018

Changes are coming to your TRICARE benefit beginning January 1st, 2018. These changes will give you more benefit choices, will improve your access to care and will simplify cost shares. The best way you can prepare is to update your information in the Defense Enrollment Eligibility Reporting System, or DEERS, sign up for TRICARE benefit updates, and visit the TRICARE changes page at TRICARE.mil/changes. Here's what you need to know:

~Currently, there are three TRICARE regions in the U.S. to

include TRICARE North, South and West. The TRICARE North and South regions will combine to form TRICARE East, while TRICARE West will remain mostly unchanged. Two new contractors, Humana Military and Health Net Federal Services, will administer these regions. This change will allow better coordination between the military hospitals and clinics and the civilian health care providers in each region.

~A new program, TRICARE Select will replace TRICARE Standard and TRICARE Extra. This change applies to both stateside and overseas. Stateside, TRICARE Select will be a self-managed, preferred provider network option. You don't need a primary care manager so you can visit any TRICARE-authorized provider for services covered by TRICARE without a referral. Overseas, TRICARE Overseas Select will be a preferred provider organization-styled plan that provides access to both network and non-network TRICARE authorized providers for medically necessary TRICARE covered services. TRICARE Select adopts a number of improvements, including additional preventive care services previously only offered to TRICARE Prime beneficiaries.

~All current TRICARE beneficiaries will be automatically enrolled into plans on January 1st, 2018, as long as you are eligible. TRICARE Prime enrollees will remain in TRICARE Prime. TRICARE Standard and Extra beneficiaries will automatically be enrolled in TRICARE Select.

~During 2018, you can choose to enroll in or change coverage plans. Enrollment will move to a

calendar year open enrollment period beginning in the fall of 2018, during which active enrollment will be required for coverage for the following year. The open enrollment period will begin on the Monday of the second full week in November and run through the Monday of the second full week in December of each calendar year.

Remember, this is your benefit – take command! And stay informed with the latest information. In the coming months, more information will be available at www.TRICARE.mil/changes. To stay informed, sign up for email alerts at www.TRICARE.mil/emailalerts. You can also get alerts by signing up for eCorrespondence in milConnect at www.dmdc.osd.mil/milconnect. 


HARVEY THE HURRICANE FLOODS THE POST'S NEIGHBORHOODS

If you recall Louis Bromfield's novel "The Rains Came" or the movie made of it, that was the experience of many parts of the Houston Metro Area on August 27th. Hurricane Harvey dumped record torrents of rainwater on Montgomery and Harris counties and many other Texas locations from the Mexican border to that of Louisiana. The result: flooding of homes, businesses, stores, schools, libraries, cars, everything! The higher elevations escaped the floods wrath, but many residents, who had never been flooded before, saw that toxic soup creep under doors and gradually swallow anything at or near floor level, and some saw

their entire ground floor awash in that blackish yellow-green water.

The impact on residents was almost the same whether the in-home depth experienced was just four inches or four feet. In all such cases, the drywall or wallboard got soaked, requiring removal to a height of two feet above the high-water mark, or usually four feet from the floor, to facilitate its replacement. Those furnishings, rugs, and contents of lower drawers, closets, bookcases, pantries, appliances, pianos, everything ended up as a huge pile on the front lawn, only to be soon followed by the drywall, cabinets, wood flooring, doors and trim. If you wanted, the better pieces might be restored professionally, but many not worth the cost ended up on the mountain out front, and some materials, like particleboard, just slumped in place adding those contents to the mix.



It came easy to ask; "Why me, Lord?", but, when all your neighbors were trying to survive with half of their lifestyle sitting wrecked on their lawns, you realized you really had little to complain about. Some had a FEMA-based flood insurance policy; others were "self-insured". But, the flood waters did not discriminate, and such risk management did not turn the flood.

Those homes impacted will present the owners with the question; "What do I do now?",

as they view the bones of their ground floor and the gaps which were once dishwashers, ranges, sinks, cabinetry and refrigerators. Then, there is the hit on the savings accounts and investments. The home you purchased a few years ago, with or without a mortgage, just lost half of its value! Perhaps you will opt to rebuild; restore the ground floor to its original or better shape. That's a six months' project at least, then replace the dining room set, the living room furnishings, the piano, the bedroom set – The curse of “the master on main”.



But, there are those who will say, “Everything happens for the best!”. Can that be? Is there a silver lining to Harvey? Did Harvey wreck so many lives without creating a chance to start anew, be it in the same location or a new one? Harvey was a downsizer for many; forcing flood victims to give up libraries of books, albums of family photos, files of important documents, those three years of income tax returns and more. In the words of Scarlett O'Hara; “As God is my witness, as God is my witness, they're not going to lick me! I'm going to live through this! ~~~Tomorrow I'll think of some way – after all, tomorrow is another day!”

THE ORIGINAL DRONE AIRCRAFT

The term “drone”, as it applies to a remotely piloted aircraft, has become common place, and their uses include the military

and civilian applications, with new uses reported almost weekly. But, the concept of a drone had its beginning during WWII, where the Eighth Air Force made use of worn-out B-17's as flying bombs over France. However, the original drone was deployed to the Pacific by the U.S.Navy, an aircraft developed from scratch.

Naval officer Delmar Fahmey was among the first visionaries to realize that remotely piloted aircraft could be used to deliver ordnance without putting airmen at risk. Fahmey was instrumental in creating three Special Task Air Groups (STAG's) to deploy drones in the Pacific Theatre.

The program, started in 1942, used cheap-to-make and easy-to-fly twin-engine drones, designated TDR-1's. These drones were a low-priority product, built by Interstate Aircraft out of pressed wood (created by piano-maker Wurlitzer) over tubular metal frames (erected by bike-maker Schwinn). Each one had a removable cockpit, so it could be ferried by a human pilot. But, it was designed to be flown via radio-control by a pilot in a TBM Avenger torpedo bomber accompanying the drone.

The secret of the TDR's was a new form of top-secret technology—an RCA television. A camera mounted in the drone's nose transmitted images back to a 5-inch screen mounted in the rear cockpit of the Avenger. Although the green, high-contrast display was crude, it was good enough for spotting ships on the horizon, which made it valuable for naval war action.

The drone program faced resistance from Navy critics, and

STAG One was not shipped to the Solomon Islands until June 1944. On July 30th, four TDR-1's flew a demonstration mission against a grounded Japanese freighter on Guadalcanal. Film of the test moved Navy brass at Pearl Harbor to grant permission to mount combat operations.

On September 27, 1944, four drones, each armed with 2,000 pound bombs, flew 55 miles to Bougainville to attack an anti-aircraft battery the Japanese had set up on a beached merchant ship. Three of the four reached the target, and two of those placed their bomb on target. Combat operations with drones continued. With the range of attacks extended to 160 miles, STAG One attacked gun installations, bridges, caves, a cargo ship and a lighthouse. The standard technique was to fly the TDR-1 directly into the target, but on occasion the drone dropped bombs remotely.

According to a Navy post-mortem; “The drone is capable of precision attack given a target of sufficient size and sufficient definition as to be visible in the television screen.” Despite modest success, and no loss of American lives, by the end of October 1944, the TDR-1's were grounded, the victims of military politics, a “not-invented-here” syndrome and general skepticism about the technology. The STAG units were disbanded and the drones discarded. Today, the last remaining TDR-1 hangs in the National Naval Aviation Museum in Pensacola, Florida. With experimental drones taking off and landing on aircraft carrier decks today, it won't be long before piloted bombers become as obsolete as the first combat drone.
