I have completed the Boys State interviews and selected two more boys to go to Austin. If you would like to sponsor a boy, get with me and **Emery** 



## MEETING HIGHLIGHTS (March 15, 2018)

With Jim Bolin acting as Commander, in the unexpected absence of Victoria Glover, the membership meeting got underwav following stipulated ritual. Then, it was immediately put into recess for a joint session with the Auxiliary to witness the Four Chaplains Memorial Service, as conducted by the Post and Unit chaplains; Bill Houghton and Geri Mulvihill. This traditional service, held usually during each February meeting, had been postponed this year due to the absence of both chaplains in February. The service was begun by singing of "America the Beautiful" and a recitation by Chaplain Houghton of the story of the February 2, 1943, sinking by enemy action of the troop transport USAT Dorchester enroute to Greenland. Four newlycommissioned, US Army chaplains were aboard, and they sacrificed their own lives to help other soldiers and crewmen to abandon the doomed ship. As witnessed by survivors in lifeboats and in the cold sea. The four chaplains gave up their own lifejackets to others, stayed on board and found watery graves. The memorial service was finely done by Bill and Geri, alternating the parts. It was much appreciated. That done, the Post's recess status was reversed and the meeting called to order.

Minutes of the 2/15/2018 membership meeting and the 3/12/2018 Executive Committee meeting had been prepared and distributed by Adjutant Pickens Jones. Those were taken up for approval. One significant omission was not found in the latter set by **Everett Ison**: At that meeting. Committeeman Art Eipper announced he was resigning his position and transferring his membership to Post 618 in Willis. He then left that meeting. but the Committee took no action in response. Now, the minutes were amended to acceptance reflect the **Eipper's** resignation. Otherwise, the two sets of minutes were adopted by voice vote.

Finance Officer Emery Heuermann was called on for his report. He had distributed a summary report to those present, and the essence of the financials as of 2/28/2018 were: General Fund: \$8,492.35;

Investment Fund: \$ 33,451.34; Total Assets: \$41,943.69. **Emery** cautioned that spread between the two funds were "untouchable" monies dedicated to a special use such as "Boys State" and "Building Fund". These are earmarked funds and are tracked as a separate matter.

Acting Commander Bolin called on any other officers for reports, and Service Officer Toby Carroll took the floor. He stated that March 29<sup>th</sup> had been proclaimed "Vietnam Veterans' Appreciation Day" and suggested that the Post do something to show its appreciation to the majority of its members. Because March 29<sup>th</sup>, a Thursday, is not a Post

meeting day, we could show appreciation at the April 19th meeting, better late than never. Toby also proposed having a representative VA from DeBakev Medical Center as a speaker at a joint Post/Auxiliary session - say, 30 minutes talk, plus Q&A. Many of the veteran problems he finds pertain to the spouse or widow of a veteran. If we need to hold a special session outside of a regular meeting, that can be done, Toby expected. **Emery** Heuermann endorsed the Vietnam veterans appreciation event and proposed it be a "homemade ice cream social" at the April meeting. That prompted the question of who were we expecting? All 'Nam vets in the Post (190)? All 'Nam vets in Montgomery County? All 'Nam vets in the Post's "pond"? Is this a recruiting effort? If we expect more than the 13 members now present, some notice must go out. There was no clear answer.

Commander Acting **Bolin** then ran through a batch of incoming mail for which he had no advance notice he would be in charge. It was difficult to understand the sender, the purpose and the issue. He reminded all of the District 7 Convention on Saturday, April 21 at Post 33 in Beaumont. This Post will as usual buy raffle tickets, contribute toward filling the Spirits Wagon and send a delegate or two. It was assumed that Commander Glover would be there.

With regard to the Spring Rummage Sale, our usual venue – the Robinson Road Community Center – is still "closed until further notice", so that leaves us once again with no sales site. At that, **Everett Ison** rose to the occasion and,

VA TRICARE SNAFU NO. 2017-92

As many as 45,000 Tricare households or beneficiaries could be dis-enrolled from Tricare coverage because their payment information was not updated when the agency changed regional contractors early this year. Affected users are retirees who use Tricare Prime and do not pay their annual fee through paycheck allotment and those who use the purchased Tricare Reserve Select, Retired Reserve and Young Adult plans. Other Tricare users, including Tricare for Life beneficiaries and activeduty families, are not impacted.

Tricare had previously been managed by three contractors in three regions: United Healthcare in the West, Health Net in the North, and Humana in the South. On January 1st, the system's South and North regions combined into Tricare East: the contractors changed to Health Net Federal Services in the West and Humana over the entire East region. As a of the changes. result purchased plan users and some Tricare Prime retirees in the former North and West regions were required to update their annual or monthly payment information or face disenrollment. Letters from Health Net dated November 18th and from Humana dated November 28th told those users that they had until December 20th and 24th respectively, to submit their payment information to the new contractors. At about the same time, Tricare announced that all enrollment updates had to be made by November 20th, in preparation for an update blackout period scheduled for December 1st to 23<sup>rd</sup>.

Now, Tricare officials say they are missing payment information for as many as 45,000

of those accounts across the two regions. Because of the December enrollment blackout, some of those users may have updated their information when instructed, only to have it lost during the transition, officials said. "It's possible that if they updated during the blackout period it may not have processed correctly, and they should check their payment information," said Kevin Dwyer, a Tricare spokesman. "It's a good idea for beneficiaries who live in the former Tricare North or West regions who pay their Tricare enrollment fees or premiums through electronic funds transfer, or via debit or credit card, to check their bank or credit card statement to make sure their Tricare fees for January and February have been paid," he said. "If not, they should contact their regional contractor to provide payment information."

Tricare officials said both Humana and Health Net are sending new letters to those who have not updated their accounts. As many as 20,000 people in Tricare East already updated their information after a new letter went out from Humana to 41,000 households early in March, Dwyer said. If payment is not received before the last paid-through date. which in many cases was January 1st, coverage will be canceled within 150 days. That means thousands of Tricare users will be dropped from the coverage books by the end of May -- 150 days from January 1st -- if the information is not payment isn't "If updated. received by the new contractor within 150 days from the last paid-through date. the beneficiary will lose Tricare coverage," Dwyer said in a statement.

Because more than one beneficiary may be in each plan, information is not readily available on how many actual Tricare users may be without coverage if the payment updates are not made. About 20,000 accounts receive disenrollment letters each month as a matter of regular business due to rejected credit cards or other problems, Tricare officials stated. They said that up to half of the current problems could be a result of those issues. "Bottom line: notices for accounts delinguent is recurring, fairly high volume, task," Dwyer said. To check if their payment option has been updated, beneficiaries in the East should contact Humana, while those in the West should contact Health Net.

All users who pay by credit or debit card must update their information by postal mail or fax. Humana users who pay through electronic funds transfer can update their information online, while HealthNet users must use a mail or fax form for that process as well.

Officials with military support organizations that represent Tricare beneficiaries said the system needs to work to make sure no one is dropped in the wake of the January 1st changes, including purchased plan users and Prime retirees. "We don't need to be disenrolling people from their earned benefits," said Kathy Beasley, a director of health affairs at the Military Officers Association of America. "We do need to do everything possible to bring people to change their payment options, but the last thing we need to be doing in the midst of this is threatening them and dis-enrolling from their care."

Frank Yoakum, who directs the Enlisted Association of the National Guard of the United States (EANGUS), said the failure to update is likely due to a lack of communication for Guard and reservists. Those members see their units only a few days a month, and are often not dialed into changes within the military community. If specific didn't give units briefings about the need to update. or provided the briefings after the changes, troops may not know they are happening. "I really think there's a contributory thing between Tricare not getting information out and the units doing the right thing," he said. [Source: Military.com | Amy Bushatz | March 22, 2018 ++|

## PUBLIC COMMENT DUE NOW ON PLACEMENT OF DESERT STORM MEMORIAL IN WASHINGTON, D.C.

The National Desert Storm War Memorial Association. cooperation with the National Park Service, is looking for comments from the public on a potential design of a memorial for Operation Desert Storm. The memorial, which Congress has authorized to be built by 2021, will honor the soldiers who served and the 383 who died in operations Desert Shield and Desert Storm. "As a Marine Corps veteran of Operation Desert Storm, I came to the startling realization six years ago that ODS was becoming a footnote in history, an insigspeed bump nificant recollected by many," wrote Scott Stump, CEO and presdent of NDSWMA, in an op-ed published by the Military Times in 2016. "We also had more 600.000 Americans than answer the call to serve, all of whom were ready to lay down their lives if required to do so. The service and sacrifice of this generation should never be forgotten."

The initial design reflects the "unique environmental and battle conditions" of the war with a curved Kuwaiti limestone wall that shields visitors from their urban surroundings and mimics the successful "lefthook" maneuver that coalition forces used, according to the NDSWMA website <a href="http://www.-ndswm.org">http://www.-ndswm.org</a>.

Through wall carvings and statues, it will also serve to educate people about the historical events of Desert Storm, identify the 34 coalition countries, and memorialize the names of all the Americans who sacrificed their lives in the war, according to the website for the Association, which is led by Honorary Board Chairman and former President George H.W. Bush, and a board of directors made up of Desert Storm veterans.

The proposed design varies for each of the three locations being considered, according to Stump. All are close to the National Mall, and the first two are near the Lincoln Memorial. The three locations are: the end of Constitution Avenue near 23rd Street NW; the Constitution Avenue Belvedere, near Rock Creek and Potomac Parkway NW; and Walt Whitman Park on E Street NW. The Association prefers the location at Constitution and 23rd for its proximity to the other war memorials and to the Lincoln Memorial, as both speak of liberation, according to Stump. "We feel that it's very important to have a memorial that's very easily accessed by pedestrians who are visiting the other war

memorials, or commemorative memorials, in West Potomac Park," Stump told the Military Times. The location is also close to the Vietnam Veterans Memorial, an important connection as many of the military's leaders in 1991 were veterans of the Vietnam War, said Stump. "In many ways this is the antithesis to Vietnam. This is their victory, their vindication as well," he said. ## BEWARE! THERE'S A NEW SCAM RUNNING AROUND

Con artists are using something called a **porting scam** (or sometimes **port-out scam**) to gain access to victims' personal and financial accounts and logins.

#### **How the Scam Works:**

- ~ Porting scams start with scammers stealing your phone number and service. How is that even possible? First, they get your name, phone number, much as personal information as they can get their hands on. Next, they call your phone company claiming to be you. They tell the company that your phone was stolen and request the phone number be ported to another device and provider
- ~ If the cell company complies, scammers gain control of your number. They begin accessing accounts that require authorization via a text message. Accounts can include email providers, social networks, invoicing software, and even online banking. Once they've bypassed that security, scammers can easily steal your identity and/or your money.

How to Avoid Porting Scams: ~ Set up two-factor authentication. In many cases, you can set up additional verification measures that would prevent a

stranger from successfully porting your phone number

- ~ Contact your provider if your phone suddenly \*stops working. If you can't make or receive phone calls or text messages, don't assume there is something wrong with your phone. Use a land line or a friend's phone to report the problem immediately to your cellular service provider.
- ~ Be alert to any signs of phishing. Be wary of any suspicious alerts from your personal or financial accounts or unsolicited requests for two-factor authorization.
- ~ Be cautious when sharing personal information. Only share your full name, phone number and other personal information with people and companies that you know and trust.

#### PATRIOTS' DAY

The holiday known as Patriots' Day was always on April 19<sup>th</sup>, the date of the anniversary of the Battles of Lexington and Concord in 1775. The day is principally observed in New England, the "cradle of liberty", but it is most commonly recognized by Massachusetts, Maine, Connecticut, Wisconsin and Florida.

It was first proclaimed "Lexington Day" in 1894 when the Lexington Historical Society petitioned the State Legislature to so designate April 19<sup>th</sup>. But, the Town of Concord followed suit, countering with "Concord Day". A compromise was reached and the name became "Patriots' Day". It also marked the first bloodshed of the Civil War which occurred in 1861 in the Baltimore Riot, where four members of the Massachusetts militia were slain and 36 were

In 1938, with the generation that fought the Civil War off the voter rolls, the Massachusetts State Legislature passed a bill which established Patriots' Day in commemoration of the opening events of the American Revolution. Observance of the day has been changed to the third Monday in April to create a three-day week-end. Thus, that

day is the annual date of the Boston Marathon and is always a Red Sox home game day. The Boston Marathon bombing in 2013 was on April 15<sup>th</sup> killing three and maiming or injuring over 100 others. Otherwise, the day is filled with parades, reenactments, band concerts and other patriotic events.





