#### MEETING HIGHLIGHTS (February 15, 2018)

[*The Bugle* at times has to stretch to find "highlights" and that was the case on the eve of February 15th. Although the weather turned warm, only eight Post members were present – a "thin blue line". If dual member Dora Blue, who was present, elected to sit with the Post, the Post would have been a wee bit bluer. And, adding to our blues, we were evicted from the usual large meeting room by a phalanx of voting machines and had to meet in a much smaller room.]

At 7:00 PM sharp, Commander Victoria Glover rapped the room to its feet and conducted the usual opening ritual, without the help of the Chaplain (absent) and the Sergeant-at-Arms (absent). Adjutant Pickens Jones had distributed copies of the minutes of the January 18, 2018, membership meeting and the February 12, 2018, Executive Committee meeting. These were reviewed by the quorum present and were approved as written by voice vote.

There was no Finance Report; the F/O Emery Heuermann was hospitalized, laid low by The First Vice influenza. Commander Jim Bolin reported on membership, stating that the Post had currently 227 paid-up members and ranked fifth among District 7 Posts. With a goal of 322, the level of goal achievement was 70,5%.

The Adjutant and Service Officer Toby Carroll had no report. Historian Win Salter stated he needed to contact Lacey Homan, who is assisting with the Yearbook, to get event photos to her. The Commander defined the schedule of interviews of high school juniors who are interested in being selected for Boys State. She is still soliciting help of Post members to participate, trying to substitute for past **Committee Chairman Dayton Denton**, who has resigned as Chairman and as Committeeman-at-Large. **Pete Koch** raised the question as to whether **Kim Biggerstaff** was handling the awards to JROTC cadet-students, but there was no one present who could answer that clearly.

First Vice Bolin rose to announce the 2018 "Birdies For Charity" fundraiser drive. He distributed pledge forms - a new design - and ran through pledge or donation the procedures. All pledges and checks must be back to Jim as of the March 15<sup>th</sup> membership meeting. The deadline of the Houston Open is March 26. Jim cited recent past-year winning Birdie numbers: 2013=(1615); 2014=(1612); 2015=(1843); 2016=(1571); 2017=(1661). The first prize is \$500.00.

The **Commander** in trying to create activity among Post members, with or without Auxiliary members, suggested a joint picnic in April, perhaps at Henry's Home-Horse & Human Sanctuary. There was no objection among the meager audience. She asked about other ideas of Post extracurricular activities. Win Salter cited Geri Mulvihill's effort to create comprehensive list of possible events and his older memo he sent her. But. as usual, good ideas just get filed, he said.

**Commander Glover** stated that the Four Chaplains Memorial Ceremony, usually held each February meeting, was rescheduled to the March meeting because of the absence of both chaplains this week. Belately, one guest (and new Post member) was introduced. He was **Greg Decwair**, fouryear USN veteran of the Vietnam War era. Welcome aboard, Greg!

There being no other business to come before the Post, the **Commander** closed the meeting in the customary manner. The members repaired to the opposite end of the room where the Auxiliary had assembled a super soup 'n salad kitchen.

[Footnote: The Auxiliary is also participating in Birdies and, during the pot-luck repast, issued a challenge to the Post, to wit: The unit which makes the highest "investment" in Birdies (valid pledges plus donations) shall be treated by the other unit to a special picnic outing at a location named by the Auxiliary on a date to be determined. It was unclear whether anyone present of the Post had the authority to accept the challenge, the **Commander** having left the building.]

The Fast Track system is exclusively a web-based platform. Whereas, veterans can simply log on to the VA web portal and submit their claims documentation, supporting medical evidence from all sources and any other documentation needed to establish their and verifv serviceconnected claim. VA doctors will have access to the Fast Track system that will enable them to take the veteran out of the role as middle man between care providers and the VA. VA doctors can then fill out the forms and submit them online quickly and easily. VA rating specialists will be able to log on the system, identify to outstanding information on the way to fully developing a claim (FDC) and give a suggested rating at the end of the automated process.

You can apply for VA disability compensation and pension online through eBenefits at <u>www.ebenefits.va.gov</u>. For disability compensation claims, you can also upload all supporting evidence you may have and make your claim a Fully Developed Claim.

~ To file a claim for VA disability compensation electronically, go to eBenefits, select Apply for Benefits and then Apply for Disability Compensation. You will need to create an eBenefits account to apply for disability compensation online

~ To file a claim for VA pension electronically, go to eBenefits, select Apply for Benefits, and then select Apply for Veterans Benefits via VONAPP. Once you submit your claim, you can track the status using eBenefits

The Fully Developed Claim (FDC) Program is the fastest way to get your claim processed and there is no risk to participate! To participate in the FDC Program, if you are making a claim for veterans disability compensation or related compensation benefits, simply submit your claim in accordance with the "FDC Criteria" shown on VA-Form 21-526EZ. Application For Disability Compensation and Related Compensation Benefits. If you are making a claim for veterans non serviceconnected pension benefits. use VA Form 21-527EZ. Application for Pension. If you are making a claim for survivor benefits, use VA Form 21-534EZ, Application for DIC, Death Pension, and/or Accrued Benefits. Forms are available at: www.va.gov/vaforms.

Veterans who find computers challenging may want to consult with their VSO or find help from a computer specialist to help them navigate the Fast Track system. #### SENATE BILL HOPES TO RESTORE SOME GUN OWNERSHIP RIGHTS LOST BY VA ACTIONS

A group of bipartisan U.S. Senators has filed legislation to reverse the fact that some vets are losing their right to keep and bear arms because their someone is handling finances. On February 6<sup>th</sup>, Senate Judiciary Chairman Chuck Grassley — joined by fellow Iowa Republican Senator Joni Ernst and West Virginia Democrat Senator Joe Manchin - introduced S.2386, which could tackle how the Department of Veterans Affairs reports veterans to the FBI's National Criminal Background Check System.

Currently, a veteran assigned a fiduciary trustee to act on their behalf is automatically declared "mentally defective" and is reported to NICS, the database Federal Firearms Licensees use to determine whether a prospective buyer is eligible to buy guns. Grassley feels to do so is a Second Amendment violation. "Veterans are losing their Second Amendment rights because they have someone managing their checkbook," Grassley said on the floor of the Senate. As of December 31, 2016, NICS had active records on 167,824 veterans reported by the VA for mental health reasons. This figure is down from 260,381 in 2015. Still, Grassley points out that 98 percent of the names in the gun check system listed by federal agencies for mental health reasons come from the VA alone.

Termed the "Veterans' Second Amendment Rights Restoration Act of 2018", the language of the bill would force

the VA to overhaul who they report to NICS. Rather than use the fiduciary rule, similar to one proposed by the Social Security Administration and repealed by Congress, the VA would have to submit individuals to a board made up of three former judicial officers or administrative law judges or through a judicial process. While it would not automatically remove those currently reported to the FBI, those with active files would be able to challenge their classification and all would be given notice by the VA of their rights to due process. "When a constitutional right is involved, the burden must always be on the government," said Grassley. The measure has been referred to the Committee on Veterans' Affairs. "The welcome kit is so simple, it's the way everything needs to work in VA," said VA Secretary Dr. David Shulkin. The kit is now available on Vets.gov and will soon be sent to all separating service members as part of VA's existing welcome home process. The Veterans Experience Office created the welcome kit using humancentered design principles, including the feed-back of more than 150 veterans throughout the country. The guide will continue to be updated based

on additional feedback and information.

The kit was distributed and warmly received at the Student Veterans of America conference in San Antonio, Texas. Veterans commented, "I wish I had this when I got out" and "I've never seen something from VA like this." While the VA kit does not provide all of the technical information on VA's pro-grams included in the Federal Benefits for Veterans, Dependents and Survivors handbook, it does provide a summarv and the steps required to enroll in VA services. ### AMERICAN LEGION AND POST 305

Each member of Post 305 elected to join The American

Legion and Post 305, being eligible for such privilege based on honorable service in a branch of the US military during a wartime era. You are wartime veterans and are recognized as such by your Legion caps and other official and casual uniform parts, patches and pins.

There is a price for such membership and some obligations too. The price is the annual dues payment. The obligations include participation in Post doings and contributions

of time and energies in support of Post programs. With over 300 members, Post 305 (and most other Posts) includes many members who have yet to be seen by the officers, who are not active in Post activities and who hardly ever come to a meeting, for one or more reasons, and those are largely **Ability, Priorities** and **Interest.** 

Ability includes the physical ability to be present, largely health and mobility issues. The Post officers and operations can do little to improve Ability. **Priorities** are the time options the member has and how a Post meeting ranks among those. Some priorities leave little choice such as evening teaching at Lone Star, or a requirement to remain at home to care for a spouse, or reluctance to drive at night. Interest is the opinion which has formed about a Post meeting as compared to other activities a member has to engage in, both in the home and out on the town. Post officers, the agendas and the programs they elect can do better to pique Interest and change the Priorities and Interest of some of you.

A never-ending challenge is obtaining dues payments within the deadlines set by the Legion. Post 305's annual dues are \$36.00, but only \$5.00 of that stays with the Post. Of the dues collected, \$31.00 per member must be sent to the Department of Texas for its operations and those of National.

The Legion year is the calendar year --- January 1 to December 31, and dues are payable in advance by October 20. Members who have not paid their dues by certain deadlines are earmarked by a modifier, per Legion By-Laws. Those who have not paid their current year dues by January 1, are labeled "delinquent". If those dues are still unpaid by February 1, the member is "suspended" and loses all Legion privileges, except for the right of reinstatement by Post vote and payment of dues. If those dues remain unpaid, the member's membership continues for a period of five months, until June 30. at which time the member is dropped from the rolls and membership has "expired". However, that member's name continues to be displayed on Post records for purposes of attempting his or her reup.

A member may "resign" from the Post at any time for various reasons, but resignation is not a recognized cause of departure. Non-payment of dues is. A member with expired membership can thereafter join another Post as a new member, or rejoin his or her old Post, but continuity of Legion membership is broken. No rebate of dues applies. Alternatively, a member in good standing may request transfer to another Post provided the receiving Post has approved the transfer. All outof-State transfers must be initiated by the receiving Post.

Legionnaires of the Texas Statewide Post 345 may at any time elect to join an active local Post. If such member's dues have been paid at Post 345, that is honored as the transfer takes place. Transfer-Ins cannot be included in the Post's goal achievement in their first year in the local Post. Eligible veterans joining the American Legion in Texas are often assigned to Post 345 as a holding action, until they select which local Post they want to join. Too many just stay there and never see nor understand the advantages of belonging to

a local Post of neighbors and friends, where they can be useful in participating in what programs and projects that Post has elected to work. Further, there are many opportunities to seek and become an officer of the local Post, where such headshed is comprised of from 10 to 12 positions, in general. All Posts seek new members who will become regular attendees and are interested enough to take on responsibility. Post 305 needs new active members, whether from the current ranks of non-actives or from Post 345 or from veterans who have yet to become a Legionnaire.

Post 305's current roster has names of 306 members and, of these, 225 have paid their current dues (year 2017-2018). The balance (81) last paid for year 2016-2017 and are "in suspension". These figures exclude ten members who have gone to final muster in the year. prominent among them being Dave Lips, Joe Watz, Dewey O'Neal and Charlie Siragusa, prominent only because of their long association with Post 305 and/or their frequent presence at meetings.

The Post's annual goal is 322, so the level of goal achievement as of March 1<sup>st</sup> is 69.9%, and, given a roster down to 306, it is unlikely we will reach more than 74% by June 30<sup>th</sup>.

But, we exist in a pool of potentials – Legionnaires who belong to the State-wide Post 345. Residing <u>within three miles</u> of our Zip are 137 Post 345 members who are paid up for 2018 or 2017. We need to wade into this pool and either "fish or cut bait". Which are you best at? Let the First Vice Commander know, ASAP.
